RESOLUTION AUTHORIZING THE CHIEF OF SAN MATEO COUNTY HEALTH OR DESIGNEE TO EXECUTE CONTRACT AMENDMENTS THAT EXTEND THE TERM OF 13 BEHAVORIAL HEALTH AND RECOVERY SERVICES AGREEMENTS FOR THREE MONTHS THROUGH JUNE 30, 2024, TO ALLOW FOR THE COMPLETION OF THE REQUEST FOR PROPOSAL PROCESS WITH THE TOTAL AMOUNT FOR THESE 13 AGREEMENTS TO BE INCREASED BY NO MORE THAN \$10,367,468

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County contracts with numerous entities to provide vital services to vulnerable members of the community; and

WHEREAS, Behavioral Health and Recovery Services has approved a three-month extension, through June 30, 2024, to allow for the completion of the Request for Proposal process and ensure that services continue uninterrupted.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and hereby authorizes the Chief of San Mateo County Health or designee to execute three month contract extensions for each of the agreements listed in Exhibit A, for FY 2023-24 allocated to the provision of direct services with the total amount for these agreements to be increased by no more than \$10,367,468.
