2014 Women In County Government Development of Self & Others Award Recipient

WHEREAS, TRISHA LIRETTE SANCHEZ, County of San Mateo Assistant Sheriff, is the highest ranking woman in the history of the Sheriff's Office and serves as a role model for all women in our organization and profession; and

WHEREAS, TRISHA LIRETTE SANCHEZ began her career as a Reserve Deputy in 1987, being hired full-time as a Correctional Officer and working her way through the ranks serving as Deputy Sheriff, Sheriff's Sergeant, Sheriff's Lieutenant, the first woman to achieve the position of Sheriff's Captain in 2003, and was appointed to her current position in 2008; and

WHEREAS, during this time, TRISHA LIRETTE SANCHEZ also developed herself by earning both a B.A. degree in Business Management and an M.A. degree in Public Sector Leadership from Saint Mary's College of California; and, she is a graduate of the FBI's National Academy, the DEA's Commander Course and the US Military Academy's West Point Leadership Program presented in conjunction with the Los Angeles Police Department; and

WHEREAS, TRISHA LIRETTE SANCHEZ has not only developed herself, she serves as an inspiration by modeling behaviors of continuing self-improvement and encourages and mentors countless others in the Sheriff's Office and elsewhere, where those interested in law enforcement have learned that hard work and a positive attitude can accomplish much; and

WHEREAS, TRISHA LIRETTE SANCHEZ's leadership has helped her perform exceptionally in a variety of challenging assignments from work in corrections, investigations, narcotics to being invited to speak at the 2014 Women in Law Enforcement Leaders Conference, her participation in the recent Sheriff's Office Recruitment Summit, and her mentorship with the Empowering Young Women Program of the Sheriff's Activity League; and

WHEREAS, TRISHA LIRETTE SANCHEZ has clearly demonstrated hard work and dedication through her exceptional personal and professional development and accomplishments,
