MEASURE K: RESOLUTION AUTHORIZING AN AMENDMENT TO THE DISTRICT-DISCRETIONARY MEASURE K GRANT AGREEMENT WITH SAN MATEO COUNTY LARGE ANIMAL EVACUATION GROUP (SMCLAEG), EXTENDING THE TERM THROUGH JUNE 30, 2025, AMENDING THE PAYMENT TERMS, AND REPLACING EXHIBITS A AND B IN THEIR ENTIRETIES, WITH NO CHANGE TO THE NOT-TO-EXCEED AMOUNT OF \$300,000, AND AUTHORIZING THE COUNTY EXECUTIVE, OR DESIGNEE, TO EXECUTE THE AMENDMENT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on December 13, 2022, the County and San Mateo County Large Animal Evacuation Group (SMCLAEG) entered into a Measure K Grant Agreement ("Agreement") for the purchase of temporary pens for the evacuation of large domestic animals during a disaster/emergency in an amount not to exceed \$300,000 for the term December 13, 2022 to November 30, 2023; and

WHEREAS, on October 31, 2023, the parties amended the Agreement to extend the term through March 31, 2024 with no change to the not-to-exceed amount of \$300,000; and

WHEREAS, on March 21, 2024, the parties further amended the Agreement to extend the term through June 30, 2024 with no change to the not-to-exceed amount of \$300,000; and

WHEREAS, the parties wish to further amend the Agreement to extend the term through June 30, 2025, amend the payment terms to provide the remainder of the grant (\$45,174.17) upon execution of this amendment, and replace Exhibits A and B in their entireties, with no change to the not-to-exceed amount of \$300,000.

WHEREAS, the Board previously approved an exception from the criteria for district-discretionary Measure K funds to allow advance payment of half the grant (\$150,000) with initial approval of the grant to SMCLAEG in December 2022; and

WHEREAS, the Board now finds that an additional exception from the criteria for district-discretionary Measure K funds is necessary and warranted to allow payment of the remainder of the grant (\$45,174.17) as an advance payment to allow SMCLAEG to promptly procure the necessary items for its operations; and

WHEREAS, it is this Board's intent for the County Executive, or designee, to execute an amendment to the agreement with San Mateo County Large Animal Evacuation Group; and

WHEREAS, this Board has been presented with a form of the amendment to the grant agreement and has examined it and approved it as to form and content and desires to enter into the amendment to the agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors authorizes the County Executive, or designee, to execute said grant agreement.

BE IT FURTHER RESOLVED that the County Executive or designee is authorized to execute amendments to the grant agreement which modify the County's maximum fiscal obligation by no more than ten percent (10%) or \$25,000 (in aggregate), whichever is less, and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
