RESOLUTION: 1. RESCINDING THE "TIME LIMITED PARKING" ZONE APPROVED BY RESOLUTION NO. 48558 ON OCTOBER 28, 1986 ON A PORTION OF THE WESTERLY SIDE OF EL CAMINO REAL (STATE ROUTE 82) SOUTH OF A STREET IN THE UNINCORPORATED COLMA AREA; AND 2. RESCINDING IN PART THE "NO PARKING" ZONES APPROVED BY RESOLUTION NO. 52508 ON MARCH 28, 1989 ON PORTIONS OF EL CAMINO REAL (STATE ROUTE 82) ADJACENT TO A STREET WITHIN THE UNINCORPORATED COLMA AREA AS DEPICTED ON EXHIBIT A

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507 et seq. and Sections
7.24.010 and 7.30.010 et seq. of the San Mateo County Ordinance Code allow this
Board of Supervisors to prohibit or restrict the stopping, parking or standing of vehicles
by resolution or ordinance with associated signs and markings in their respective
jurisdictions on a state highway if the resolution or ordinance establish said restrictions
are first submitted and approved in writing by the Department of Transportation; and

WHEREAS, the Director of Public Works has recommended that certain "Time Limited Parking" and "No Parking" zones be rescinded as noted herein and as depicted on Exhibit A attached hereto; and

WHEREAS, parking restrictions may apply to state highways provided the resolution or ordinance establishing said restrictions are submitted and approved in writing by the California Department of Transportation; and

WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

1. The "2-Hour Time Limited Parking" zone established per Resolution No. 48558, on October 28, 1986 at the following location shall be rescinded:

"On the westerly side of El CAMINO REAL, State Highway No. 82, commencing at a point 100 feet southerly of the intersection of EL CAMINO REAL and "A" STREET, County Road No. 167 to a point 40 feet southerly of said intersection, a distance of 60 feet, more or less."

- 2. The "No Parking" zones established per Resolution No. 52508, on March 28, 1989 at the following locations only shall be rescinded:
 - A) "No Parking Zone on the easterly side of El Camino Real (State Route 82) beginning at "A" Street and extending 83 feet northerly."
 - B) "No Parking Zone on the westerly side of El Camino Real (State Route 82) beginning at "A" Street and extending 83 feet southerly."
- The Director of Public Works is authorized to send a copy of this Resolution to the California Department of Transportation to review and approve in writing such changes.
