**RESOLUTION AUTHORIZING AN AGREEMENT WITH DATA INNOVATIONS LLC,  
TO PROVIDE THEIR INSTRUMENT MANAGER SOFTWARE TO INTEGRATE LAB  
INSTRUMENTS FOR THE NEW ELECTRONIC HEALTH RECORD SOLUTION FOR  
SAN MATEO COUNTY HEALTH FOR THE TERM OF JANUARY 9, 2024 THROUGH  
JANUARY 8, 2029, IN AN AMOUNT NOT TO EXCEED \$324,711**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the new Electronic Health Record (EHR) solution requires a Lab Instrument Management Software that will integrate into the new solution; and

**WHEREAS**, the existing software is vendor-specific and unable to connect to Epic to provide seamless interaction with the EHR; and

**WHEREAS**, with the selection of Epic as San Mateo County Health's (SMCH's) new integrated EHR system, it is necessary to utilize Data Innovations LLC's Instrument Management Software, which allows SMCH to become much more automated and efficient utilizing the new EHR solution; and

**WHEREAS**, the Data Innovations LLC's Instrument Management Software enables the lab systems instruments to connect to the EHR to share patient specimens, orders, and results electronically, in addition allows for the efficient processing of Quality Assurance specimens; and

**WHEREAS**, Data Innovations LLC's software is the only known application that

works with the County's chosen EHR solution, is only available from a single source, and has unique performance factors; and

**WHEREAS**, Data Innovations LLC wants to enter into an agreement with SMCH to provide an Instrument Management Software that is fully integrated with Epic, in an amount not to exceed \$324,711, for the term of January 9, 2024 through January 8, 2029; and

**WHEREAS**, this Board has been presented with a form of the agreement and has examined and approved it as to both form and content and desires to enter into it.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of this Board of Supervisors is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Chief of San Mateo County Health or their designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
