FIRST AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND CHILD CARE COORDINATING COUNCIL OF SAN MATEO COUNTY

THIS AMENDMENT TO THE AGREEMENT, entered into this 23 of January 2024, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Child Care Coordinating Council of San Mateo County, hereinafter called "Contractor";

<u>WITNESSETH</u>:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for child care services for CAPP eligible families on June 13, 2023 for the term of July 1, 2023 through June 24, 2024 for a total obligation not to exceed \$2,766,731.00; and

WHEREAS, the parties wish to amend the agreement to extend the term by one (1) year for a revised period of July 1, 2023 through June 30, 2025, and to increase the total obligation amount by \$4,085,396.00 for a revised total not to exceed amount of \$6,852,127.00.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- **1.** Section 4. Payments, paragraph 1 of the Agreement is amended to read as follows:
 - In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth herein and in Exhibits A and C, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed SIX MILLION, EIGHT HUNDRED FIFTY-TWO THOUSAND, ONE-HUNDRED TWENTY-SEVEN DOLLARS (\$6,852,127.00).
- **2.** Section 5. Term and Termination, the first sentence of the Agreement is amended to read as follows:
 - Subject to compliance with all terms and conditions, the term of this Agreement shall be

from July 1, 2023 through June 30, 2025.
