ELECTION") WITH ELECTIONS CALLED BY COUNTY SERVICE AREA NO. 1,
JEFFERSON ELEMENTARY SCHOOL DISTRICT, PACIFICA SCHOOL DISTRICT,
SAN CARLOS SCHOOL DISTRICT, AND WOODSIDE ELEMENTARY SCHOOL
DISTRICT; AND B) AUTHORIZING THE COUNTY'S CHIEF ELECTIONS OFFICER
TO RENDER SPECIFIED ELECTION SERVICES IN CONJUNCTION WITH THE
PRESIDENTIAL PRIMARY ELECTION TO BE HELD ON TUESDAY, MARCH 5, 2024

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Election Code Sections 10400 through 10418 authorize this Board to order the consolidation of elections that are called to be held on the same day in or within the same territory upon the order of the governing body or bodies calling the elections and, if ordered, the consolidated election shall be held in all respects as if it were one election, with the returns being canvassed by the County's Chief Elections Officer; and

WHEREAS, absent other arrangements or applicable law, the costs of any school district election shall be borne by the school district holding the election pursuant Education Code Section 5421, and any city or district shall reimburse the County in full for the services performed by the County's Chief Elections Officer in accordance with Division 10 of the Elections Code; and

WHEREAS, pursuant to state law, this Board, as the governing board of County Service Area No. 1, adopted Resolution No. 080011, giving notice of holding an election on March 5, 2024 for the purpose of submitting a special tax measure to County Service Area No. 1 voters, and requesting the County's Chief Elections Officer to render specified election services to County Service Area No. 1 therefor; and

WHEREAS, pursuant to state law, the governing board of the Jefferson Elementary School District adopted Resolution No. 23-11-08, giving notice of holding an election on March 5, 2024 for the purpose of submitting a parcel tax measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the governing board of the Pacifica School District adopted Resolution No. 2023-11-15-A, giving notice of holding an election on March 5, 2024 for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the governing board of the San Carlos School District adopted Resolution No. 8:23/24 giving notice of holding an election on March 5, 2024 for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the governing board of the Woodside

Elementary School District adopted Resolution No. 2024-01, giving notice of holding an

election on March 5, 2024 for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, each of the aforementioned local governing bodies has requested that their respective elections, as described in the above findings, be consolidated with the March 5, 2024 Presidential Primary Election ("March 2024 Primary Election"); and

WHEREAS, the County's Chief Elections Officer is agreeable to providing specified election services requested and enumerated in the above findings in conjunction with the March 2024 Primary Election; and

WHEREAS, in consideration of the services to be provided by the County's Chief Elections Officer in conducting the elections described in the above findings, each local governing body requesting such services will, as required by law, enter into separate agreements with the County's Chief Elections Officer to outline the services to be rendered and to reimburse the County for the costs of said services.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the March 2024 Primary Election is hereby consolidated with the local elections described in this Resolution duly called by their respective governing bodies.

**BE IT FURTHER RESOLVED** that the County's Chief Elections Officer is authorized to provide specified election services in conjunction with the March 2024 Primary Election.
