RESOLUTION HONORING AND COMMENDING**

**SAN MATEO COUNTY COMMUNITY HEROES WHO RESPONDED TO THE HALF MOON BAY SHOOTING OF
JANUARY 23, 2023**

WHEREAS, on January 23, 2023, San Mateo County suffered a devastating mass shooting event in Half Moon Bay, resulting in the deaths of seven individuals; and the response by law enforcement, medical professionals, local leaders, state leaders, federal leaders, and the community was immediate, robust, culturally sensitive, and comprehensive, and ensuring the long-term support for the recovery and stability of victims and families.
