SIXTH AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND SIEMENS MEDICAL SOLUTIONS USA, INC.

THIS AMENDMENT TO THE AGREEMENT, entered into on	by and between the
COUNTY OF SAN MATEO, hereinafter called "County," and SIEM	ENS MEDICAL SOLUTIONS USA, INC, hereinafter
called "Contractor";	

WITNESSETH:

WHEREAS, the parties entered into an Agreement with SIEMENS MEDICAL SOLUTIONS USA, INC. to maintain and upgrade County's Radiology Information System (RIS) also known as Syngo Workflow, at the San Mateo Medical Center (SMMC) within San Mateo County Health, on January 23, 2018 for the term of February 1, 2018 through December 31, 2020, in the amount not to exceed \$300,000; and

WHEREAS, the parties entered into a first amendment to the Agreement on May 15, 2018 to correct the amount of the Sybase fee to be deleted when the upgrade is completed and to extend the timing of the second upgrade payment; and

WHEREAS, the parties entered into a second amendment to the Agreement on October 6, 2020 to extend the term by three years, from December 31, 2020 to December 31, 2023 and increase the County's total fiscal obligation by \$205,000 for an amount not to exceed \$505,000; and

WHEREAS, the parties entered into a third amendment to the Agreement on May 8, 2023 to add a one-year Easysoft ODBC-SQL subscription; and

WHEREAS, the parties entered into a fourth amendment to the Agreement on October 3, 2023 to extend the term by one year, from December 31, 2023 to December 31, 2024 with an option to extend the Agreement one additional year, to December 31, 2025, and increase the County's total fiscal obligation by \$46,000 for an amount not to exceed \$551,000; and

WHEREAS, the parties entered into a fifth amendment to the Agreement on March 11, 2024 to exercise the option approved by the County Board of Supervisors on October 3, 2023 (Section 3 of amendment four) to extend the term by one year, from December 31, 2024 to December 31, 2025 and increase the County's total fiscal obligation by \$46,000 for an amount not to exceed \$597,000; and

WHEREAS, the parties wish to enter into a sixth amendment to the Agreement to establish a Single Server Archive Solution and increase the County's total fiscal obligation by \$44,880 for an amount not to exceed \$641,880.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3, (entitled "Payments"), as amended, is hereby further amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed **SIX HUNDRED FOURTY**-

ONE THOUSAND EIGHT HUNDRED EIGHTY DOLLARS (\$641,880). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement. All invoices must be approved by the County Health CIO or their designee. Invoices must be sent to: hs_hit_accountspayable@smcgov.org. Processing time may be delayed if invoices are not submitted electronically.

- 3. All other terms and conditions of the Agreement between County and Contractor, shall remain in full force and effect.
