RESOLUTION AUTHORIZING A REVENUE AGREEMENT WITH GREEN TOYS, INC. FOR WAREHOUSING, PACKAGING, AND SHIPPING AND RECEIVING SERVICES PERFORMED BY VOCATIONAL REHABILITATION SERVICES CLIENTS THROUGH THE WORKCENTER TRAINING PROGRAM, FOR THE TERM OF MAY 21, 2024 THROUGH MAY 20, 2027, WITH AN ANTICIPATED REVENUE AMOUNT NOT TO EXCEED \$500,000

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that;

WHEREAS, San Mateo County residents with disabilities and/or barriers to employment benefit from hands-on training in order to obtain jobs, and the Human Services Agency's Vocational Rehabilitation Services (VRS) WorkCenter provides hands-on job training for such residents (clients); and

WHEREAS, VRS WorkCenter is a competitively priced subcontractor for local companies providing high-quality, labor-intensive services such as packaging, shrink wrapping, labeling, pick up, and delivery and fulfillment, and offers a closely supervised workforce of more than 100 trainees in a 35,000 square foot production facility; and

WHEREAS, VRS continually looks for opportunities to provide services to outside entities such as Green Toys, Inc. (Green Toys), which would allow for real world training of clients; and

WHEREAS, both VRS WorkCenter and Green Toys now wish to enter into an agreement whereby VRS will provide warehousing, packaging, and shipping and

receiving services to Green Toys for the term of May 21, 2024 through May 20, 2027,
with an anticipated revenue amount not to exceed \$500,000; and

WHEREAS, there has been presented to this Board of Supervisors for its
consideration and acceptance a revenue agreement, reference to which is hereby made
for further particulars.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the
President of the Board of Supervisors be and is hereby authorized and directed to
execute said revenue agreement for and on behalf of the County of San Mateo, and the
Clerk of this Board shall attest the President's signature thereto.
