RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH GENUENT GLOBAL LLC FOR THE SERVICES OF DEEPA NARAYAN, EXTENDING THE TERM FROM JULY 21, 2020 THROUGH SEPTEMBER 30, 2023 TO JULY 21, 2020 THROUGH JANUARY 31, 2023, AND INCREASING THE AMOUNT PAYABLE BY \$58,568 TO AN AMOUNT NOT TO EXCEED \$583,876

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on July 21, 2020, the County entered into an Agreement with Genuent Global LLC to provide Quality Assurance Testing services through June 30, 2022 in the amount of \$340,956; and

WHEREAS, on June 28, 2022, the parties amended the Agreement (Amendment 1, BOS Resolution # 078970) to extend the term from July 21, 2020, through June 30, 2022 to July 21, 2020 through March 31, 2023, and increase the amount payable by \$100,370 for an amount not to exceed \$441,326; and

WHEREAS, on March 28, 2023, the parties amended the Agreement (Amendment 2, BOS Resolution # 079505) to extend the term from July 21, 2020 through March 31, 2023 to July 21, 2020 through September 30, 2023, and increase the amount payable by \$83,982, to an amount not to exceed \$525,308; and

WHEREAS, the County and Genuent Global LLC now wish to further amend the Agreement to extend the term from July 21, 2020 through September 30, 2023 to July 21, 2020 through January 31, 2024, and increase the amount payable by \$58,568, to an amount not to exceed \$583,876; and

WHEREAS, this Board has been presented with a form of such Amendment, has examined and approved it as both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED:

1. The President of the Board of Supervisors be and is hereby authorized and directed to execute Amendment 3 to Agreement with Genuent Global LLC, for quality assurance testing services for the Assessor Property Assessment System (APAS) on behalf of the County of San Mateo, and the Clerk of the Board shall attest to the President's signature thereto.

2. Authority is given to the Assessor-County Clerk-Recorder & Chief Elections Officer or designee to execute contract amendments to modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services as long as the modified term of services is/are within the current or revised fiscal provision.
