**RESOLUTION AUTHORIZING AN AGREEMENT WITH REDWOOD CITY SCHOOL DISTRICT TO PROVIDE MENTAL HEALTH SUPPORT TO SAN MATEO COUNTY NEWCOMERS, AND AUTHORIZING THE CHIEF OF HEALTH OR THEIR DESIGNEE TO EXECUTE AGREEMENTS WITH TWO ADDITIONAL VENDORS WHEN NEGOTIATIONS ARE CONCLUDED, FOR THE TERM OF OCTOBER 21, 2025 THROUGH OCTOBER 21, 2027, IN AN AGGREGATE AMOUNT FOR THREE AGREEMENTS NOT TO EXCEED \$600,000**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, there has been presented to this Board of Supervisors for its consideration and acceptance an agreement, reference to which is hereby made for further particulars, whereby Redwood City School District to provide mental health support to San Mateo County newcomers pursuant to a Request for Proposal (RFP) process which resulted in an award to three separate vendors including, in addition to Redwood City School District, Fresh Approach and Anamatang: Polynesian Voices; and

**WHEREAS**, this Board further authorizes the Chief of Health or their designee to execute agreements when negotiations are concluded with two additional vendors for the remaining two priority focus areas for the term of October 21, 2025 through October 21, 2027, in an aggregate amount for the three agreements not to exceed \$600,000; and

**WHEREAS**, this Board has been presented with the agreement with Redwood City School District for mental health support for the term of October 21, 2025 through

October 21, 2027, for an amount not to exceed \$200,000 and has examined and approved it as to both form and content and desires to enter into the agreement.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of this Board of Supervisors be and is hereby authorized and directed to execute said agreement with the Redwood City School District for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Chief of San Mateo County Health or their designee is authorized to execute agreements with the two other vendors determined pursuant to the RFP, specifically, Fresh Approach and Anamatang: Polynesian Voices, following conclusion of negotiations within the fiscal parameters of this resolution, i.e. for terms not extending past October 21, 2025 and in amounts not exceeding \$200,000 for each vendor.

**BE IT FURTHER RESOLVED** that the Chief of San Mateo County Health or their designee be authorized to execute amendments to the agreement which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
