RESOLUTION AUTHORIZING: A)THE ACCEPTANCE OF ANNUAL COMMUNITY SERVICES BLOCK GRANT (CSBG) FUNDS AND CSBG DISCRETIONARY FUNDS FROM THE STATE DEPARTMENT OF COMMUNITY AND SERVICES DEVELOPMENT (CSD) TO PROVIIDE EMERGENCY ASSISTANCE TO LOW-INCOME FAMILIES AND INDIVIDUALS IN A TOTAL AMOUNT NOT TO EXCEED \$2,000,000; AND B) THE HUMAN SERVICES AGENCY (HSA) DIRECTOR, OR DESIGNEE, TO EXECUTE AGREEMENTS WITH CSD AND ANY AMENDMENTS TO THOSE AGREEMENTS REQUIRED FOR ACCEPTANCE OF ANNUAL CSBG FUNDS AND CSBG DISCRETIONARY FUNDS IN A TOTAL AMOUNT NOT TO EXCEED \$2,000,000 RECEIVED FROM JANUARY 1, 2025 THROUGH MAY 31, 2028; AND C) THE HSA DIRECTOR, OR DESIGNEE, TO EXECUTE AGREEMENTS WITH QUALIFIED CONTRACTOR(S) AND ANY AMENDMENTS TO THOSE AGREEMENTS TO ADMINISTER CSBG FUNDS AND CSBG DISCETIONARY FUNDS IN A TOTAL AMOUNT NOT TO EXCEED FUNDS ALLOCATED

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the State Department of Community Services and Development (CSD) awards annual amounts of Community Services Block Grant (CSBG) Funds to counties and partner agencies to provide services to low-income individuals throughout the State of California in an effort to reduce poverty; and

WHEREAS, when CSD has additional funds, it also often issues CSBG

Discretionary Funds to provide additional services for low-income communities; and

WHEREAS, the Human Services Agency (HSA) utilizes these funding resources to contract with qualified community-based organizations to provide emergency financial assistance to low-income families and individuals in San Mateo County so that they can remain housed; and

WHEREAS, CSD anticipates allocating \$473,796 in CSBG Funds to HSA for the 2025, 2026, and 2027 calendar years, but the final amount may be more or less than this estimated amount, depending on CSD's final budget allocations of each year; and

WHEREAS, in order to comply with the timing of CSD's contract process and to ensure the provision of critical services to the community in a timely manner, HSA is requesting this Board authorize the Human Services Director or his/her designee to execute agreements and any necessary amendments with CSD required to accept CSBG Funds and CSBG Discretionary Funds in an amount not to exceed \$2,000,000 for the term of January 1, 2025, through May 31, 2028; and

WHEREAS, for the same reason, HSA is also requesting the Board to authorize the Human Services Director or his/her designee to execute agreements and any necessary amendments to those agreements with qualified contractor(s) to administer such CSBG Funds and CSBG Discretionary Funds.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to accept CSBG funds and CSBG discretionary funds from the State Department of Community and Services Development to provide emergency assistance to low-income families and individuals in a total amount not to exceed \$2,000,000 for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto

BE IT FURTHER RESOLVED that the Human Services Agency Director or his/her designee is authorized to execute agreements with the State Department of Community Services and Development and any amendments to those agreements required for the acceptance of CSBG and CSBG discretionary funds in a total amount not to exceed \$2,000,000 received from January 1, 2025 through May 31, 2028.

BE IT FURTHER RESOLVED that the Human Services Agency Director or his/her designee is authorized to execute agreements with qualified contractor(s) and any amendments to those agreements to administer such CSBG Funds and CSBG Discretionary Funds in a total amount not to exceed funds allocated.
