FIFTH AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND HAEMONETICS, INC

THIS AMENDMENT TO THE AGREEMENT, entered into this day of,
2025, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Haemonetics, Inc.
hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, Haemonetics and Customer entered into an Agreement for blood bank information system services on October 18, 2016 for the term of September 1, 2016 through August 31, 2021, in an amount not to exceed \$250,000 are parties to a Master Agreement effective September 8, 2016 (the "Agreement"); and

WHEREAS, the parties amended the Agreement on July 17, 2017, including additional services and increasing the maximum amount by \$25,000 to an amount not to exceed \$275,000; and

WHEREAS, the parties amended the Agreement on May 17, 2021, extending the term through March 31, 2025; and

WHEREAS, the parties amended the Agreement on February 13, 2024, to include EPIC integration services and increase the amount of the Agreement by \$210,000 to an amount not to exceed \$485,000; and

WHEREAS, the parties amended the Agreement on April 25, 2024, to increase the amount of the Agreement by \$25,000 to an amount not to exceed \$510,000; and

WHEREAS, the parties wish to amend the Agreement to increase the amount of the Agreement by \$2,000 to an amount not to exceed \$512,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3.1, Invoices & Payments, of the agreement is amended to read as follows:

Fees and dates for invoicing of such fees are specified in the Fee Schedule. Customer shall pay to Haemonetics all applicable fees net thirty (30) days from the date of Haemonetics' invoice. In no event shall total payments under this Agreement exceed FIVE HUNDRED TWELVE THOUSAND DOLLARS (\$512,000).

2. All other terms and conditions of the agreement, as previously amended, between the County and Contractor shall remain in full force and effect.
