RESOLUTION: A) RESCINDING IN PART THE "TWO HOUR LIMITED PARKING"
ZONES ON MIDDLEFIELD ROAD THAT WERE PREVIOUSLY APPROVED BY THIS
BOARD BY RESOLUTION NO. 067697 ON DECEMBER 6, 2005; AND
B) ESTABLISHING FIVE "20-MINUTE LIMITED PARKING" ZONES ON
MIDDLEFIELD ROAD NEAR DUMBARTON AVENUE AND FIFTH AVENUE IN
UNINCORPORATED NORTH FAIR OAKS DURING SPECIFIED HOURS AND DAYS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507, et seq., and Section 7.24.010 of the San Mateo County Ordinance Code allow this Board of Supervisors to prohibit or restrict the stopping, parking, or standing of vehicles by resolution or ordinance with associated signs and markings; and

WHEREAS, the Department of Public Works (Department) recently completed the Middlefield Road Improvement Project (Project), and, as part of the Project, new bus stops were constructed to comply with the current SamTrans' bus stop standards; and

WHEREAS, the new bus stops are longer than the previous bus stops and require additional no-parking areas compared to what existed previously, which have impacted the nearby businesses; and

WHEREAS, to address these concerns, the Department engaged in discussions with SamTrans and affected business owners along Middlefield Road to gather their input; and

WHEREAS, SamTrans has indicated that the new bus stops built to their current bus stop standards are necessary to provide appropriate service for all bus users and that deviating from the standard is not feasible; and

WHEREAS, the business owners indicated the need to encourage turnover of parking spaces and ensure availability for short term visits; and

WHEREAS, this Board adopted Resolution No. 067697, which authorized previous parking restrictions for "Two Hour Time Limited" zones along Middlefield Road, which must be rescinded in part to facilitate establishing revised parking restrictions in this area; and

WHEREAS, the Director of Public Works has recommended that five (5) "20Minute Time Limited Parking" zones be established as noted herein and on Exhibit A
attached hereto; and

WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

 "Two Hour Time Limited Parking" zones established per Resolution No. 067697, on December 6, 2005, for Middlefield Road at the following locations be rescinded:

- A) On the easterly side of Middlefield Road commencing one-hundred forty-one feet (141.0') north of the centerline of Dumbarton Avenue, extending northerly a distance of 20 feet, more or less.
- B) On the westerly side of Middlefield Road commencing sixty feet (60.0') north of the centerline of Dumbarton Avenue, extending northerly a distance of 20 feet, more or less.
- C) On the easterly side of Middlefield Road commencing seventy-eight feet (78.0') south of the centerline of Dumbarton Avenue, extending southerly a distance of 20 feet, more or less.
- D) On the westerly side of Middlefield Road commencing one-hundred forty-six feet (146.0') south of the centerline of Dumbarton Avenue, extending southerly a distance of 20 feet, more or less.
- E) On the easterly side of Middlefield Road commencing one-hundred sixty-two feet (162.0') north of the centerline of Fifth Avenue, extending northerly a distance of 20 feet, more or less.
- "20-Minute Time Limited Parking" zones be established along Middlefield Road within the unincorporated North Fair Oaks area at the following locations:
 - A) On the easterly side of Middlefield Road commencing one-hundred forty-one feet (141.0') north of the centerline of Dumbarton Avenue, extending northerly a distance of 20 feet, more or less.
 - B) On the westerly side of Middlefield Road commencing sixty feet (60.0') north of the centerline of Dumbarton Avenue, extending northerly a distance of 20 feet, more or less.

- C) On the easterly side of Middlefield Road commencing seventy-eight feet (78.0') south of the centerline of Dumbarton Avenue, extending southerly a distance of 20 feet, more or less.
- D) On the westerly side of Middlefield Road commencing one-hundred forty-six feet (146.0') south of the centerline of Dumbarton Avenue, extending southerly a distance of 20 feet, more or less.
- E) On the easterly side of Middlefield Road commencing one-hundred sixty-two feet (162.0') north of the centerline of Fifth Avenue, extending northerly a distance of 20 feet, more or less.
- The Department of Public Works is authorized and directed to post any necessary signs and pavement markings.
