**RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH TRIUNE INFOMATICS, INC. FOR THE SERVICES OF SUDEEPHI RANGINENI, EXTENDING THE TERM FROM FEBRUARY 4, 2022 THROUGH APRIL 30, 2023 TO FEBRUARY 4, 2022 THROUGH SEPTEMBER 30, 2023, AND INCREASING THE AMOUNT PAYABLE BY \$58,464 TO AN AMOUNT NOT TO EXCEED \$250,568**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, on February 4, 2022, the County entered into an Agreement with Triune Infomatics, Inc. to provide Quality Assurance Testing services through April 30, 2023 in the amount of \$121,872; and

**WHEREAS**, on June 15, 2022, the parties amended the Agreement to replace the contractor Ms. Kamini Wagulde with Ms. Sudeepthi Rangineni and increase the amount by \$70,232 to a new amount of \$192,104; and

**WHEREAS**, the County and Triune Infomatics, Inc. now wish to further amend the Agreement to extend the term from February 4, 2022 through April 30, 2023 to February 4, 2022 through September 30, 2023, and increase the amount payable by \$58,464, to an amount not to exceed \$250,568; and

**WHEREAS**, this Board has been presented with a form of such Amendment, has examined and approved it as both form and content, and desires to enter into it.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED:**

1. The President of the Board of Supervisors be and is hereby authorized and

directed to execute Amendment 2 to Agreement with Triune Infomatics, Inc., for quality assurance testing services for the Assessor Property Assessment System (APAS) on behalf of the County of San Mateo, and the Clerk of the Board shall attest to the President's signature thereto.

2. Authority is given to the Assessor-County Clerk-Recorder & Chief Elections Officer or designee to execute contract amendments to modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services as long as the modified term of services is/are within the current or revised fiscal provision.
