Re: Pharmacy Services Agreement effective July 1, 2011 between San Mateo Medical Center and Cardinal Health Pharmacy Services, LLC ("Agreement")

Dear Mr. Horne:

Effective August 1, 2017, this letter serves to increase the Contract Value and Not-To-Exceed Amount of the above-referenced Agreement by an additional one hundred thousand dollars (\$100,000).

Paragraph 2.04 (d) of the Agreement shall be replaced in its entirety as follows:

**2.04** Monthly Fees

d. Contract Value and Not To Exceed Amount. The Parties agree that this contract is valued at eight hundred eighty five thousand dollars (\$885,000). This is based on an estimated volume of four thousand (4,000) Order Lines processed each month at four dollars (\$4.00) per Order Line. Actual contract value may be higher or lower should Customer's Order Line volume exceed or not reach four thousand (4,000) Order Lines per month and based on other factors. However, in no circumstance shall Customer's fiscal obligation under this Agreement exceed \$885,000 and Cardinal Health shall not be required to perform services beyond this not-to-exceed amount. Any change in this amount requires a written amendment to this Agreement.

All terms and conditions of the Agreement not supplanted or supplemented herein shall remain unaltered and in full force and effect. To the extent that there is any conflict between this Letter Agreement and the Agreement, this Letter Agreement shall control.
