**RESOLUTION AUTHORIZING A ONE-TIME GRANT OF DISTRICT-DISCRETIONARY MEASURE K FUNDS, NOT TO EXCEED \$90,000, TO GENERATIONS UNITED TO HIRE STAFF TO SUPPORT AND EXPAND PROGRAMMING INCLUDING SUMMER CAMPS AND FITNESS CLASSES FOR UNDERSERVED CHILDREN AND FAMILIES, AND ENABLE GENERATIONS UNITED TO OFFER ADDITIONAL SPANISH-LANGUAGE COURSES IN BUSINESS PLANNING TO BUSINESS OWNERS IN UNINCORPORATED NORTH FAIR OAKS AND REDWOOD CITY, PROVIDING AN EXCEPTION TO THE CRITERIA FOR DISTRICT-DISCRETIONARY MEASURE K FUNDS TO ALLOW REPEAT FUNDING WITHIN THE CURRENT BUDGET CYCLE, AND AUTHORIZING THE COUNTY EXECUTIVE, OR DESIGNEE, TO EXECUTE THE GRANT AGREEMENT**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, **Measure K** is the half-cent general sales tax initially approved by San Mateo County voters in November 2012, and extended in November 2016 for a total of thirty years; and

**WHEREAS**, the Board and County staff have conducted study sessions and community outreach efforts to inform priorities for **Measure K** spending; and

**WHEREAS**, on March 9, 2021, and March 23, 2021, the Board held study sessions on **Measure K** expenditures and anticipated revenue for fiscal years (FY) 2021-23, and approved the allocation of \$5 million in one-time loans or grants for the FY 2021-23 budget cycle, divided equally among the supervisorial districts, for district-discretionary needs and projects; and

**WHEREAS**, this is a request to authorize a one-time grant of Measure K funds, in the amount of \$90,000, to Generations United; and

**WHEREAS**, this item is consistent with the criteria for district-discretionary **Measure K** funds approved by the Board in December 2018, with the following exception: the grant would be the second grant of district-discretionary funding to the same organization within the current FY 2021-23 budget cycle; and

**WHEREAS**, the Board finds that the exception is warranted in this instance to allow for funding of 2023 summer and fall programs for underserved youth, families and immigrant-led businesses, given the ever-growing need for such programs as well as a shortage of comparable programs available to District 4 residents; and

**WHEREAS**, there are sufficient **Measure K** funds in the Non-Departmental Services FY 2021-22 Adopted Budget for this purpose; and

**WHEREAS**, it is the Board's intent for the County Executive, or designee, to execute an agreement in the amount of \$90,000 to Generations United, and setting forth the terms of the grant in furtherance of the objectives set forth in the Project Summary section in the Board transmittal accompanying this resolution; and

**WHEREAS**, this Board has been presented with a form of the grant agreement and has examined it and approved it as to both form and content and desires to enter into the agreement.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors approves of said grant, and authorizes the County Executive, or designee, to execute said grant agreement.

**BE IT FURTHER RESOLVED** that the County Executive or designee is authorized to execute amendments to the grant agreement which modify the County's maximum fiscal obligation by no more than ten percent (10%) or \$25,000 (in aggregate), whichever is less, and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
