### Glossary

**Board Retreat:** Board retreats provide the Board of Supervisors with dedicated time to step back from regular meetings to engage in strategic planning, set policy priorities, strengthen governance and collaboration, and align on long-term goals for the county.

**Budget Hearings:** Budget hearing meetings provide the Board of Supervisors with a public forum to review, discuss, and evaluate the proposed county budget, ensure alignment with community priorities and legal requirements, and allow for public input before adopting the final budget.

**Quarterly Legislative Priorities Update:** Legislative Priorities updates keep the Board of Supervisors informed on the status of adopted legislative priorities, emerging policy issues, and advocacy efforts, enabling timely guidance, alignment, and informed decision-making.

**Quarterly Poetry Reading:** Quarterly Poetry Readings provide a platform for community members and artists to share creative expression, celebrate local culture, and foster community engagement within the Board of Supervisors' meetings
