AMENDMENT NO. FOUR TO AGREEMENT

BETWEEN THE COUNTY OF SAN MATEO AND Karla's Janitorial Services & Suppliers

THIS AMENDMENT TO THE AGREEMENT, entered into this	$_$, 20 $_$, by and between the COUNT
OF SAN MATEO, hereinafter called "County," and Karla's Janitorial Serv	vices & Suppliers, hereinafter called
"Contractor";	

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, under Resolution No. 078455 authorized by the County Board of Supervisors, the parties entered into an Agreement for janitorial custodial services at various County building locations from October 1 2021 through September 30, 2024 in an amount not-to-exceed \$1,298,980.08 on October 1, 2021; and

WHEREAS, on May 1, 2024, as authorized by Resolution No. 078455, the parties amended the Agreement to increase the not-to-exceed amount by \$300,000 for a new not-to-exceed amount of \$1,598,980.08 and extended the term through March 31, 2025; and

WHEREAS, on April 1, 2025, as authorized by Resolution No. 078455, the parties amended Agreement to extend the term of the agreement through April 30, 2025 with no change in amount; and

WHEREAS, on April 22, 2025, as authorized by Resolution No. 081102, the parties amended the Agreement to increase the not-to-exceed amount by \$255,609.72 for a new not-to-exceed amount of \$1,854,589.80 and extended the term through October 31, 2025; and

WHEREAS, the parties wish to amend the Agreement to increase the not-to-exceed amount for an additional \$324,493.68 for a new not-to-exceed amount up to \$2,179,083.48 and extend the term for an additional eight months through June 30, 2026.

WHEREAS, the parties have agreed to amend the term of the Agreement on a month-to-month basis from July 1, 2026 through October 31, 2026, if necessary, at \$40,561.71 per month, for continuity of custodial services.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3. Payments of the agreement is amended to read as follows:

In no event shall County's total fiscal obligation under this agreement exceed Two Million One Hundred Seventy-Nine Thousand Eighty-Three Dollars and 48/100 Dollars (\$2,179,083.48).

2. Section 4. Term of the agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from October 1, 2021 through June 30, 2026.

3. Other Changes:

Exhibit B is hereby amended to state, "The maximum fiscal obligation and not-to-exceed amount for this contract is \$2,179,083.48."

Attachment A - Facility Breakdown Sheet is hereby amended to include cost breakdown for the extended term of the Agreement. Please see "Attachment A".

4. All other terms and conditions of the agreement dated October 1, 2021, between the County and Contractor shall remain in full force and effect.
