**WHEREAS, Sheila Gilson**, Senior Vice President of Kaiser Permanente Health Plan and Hospital Operations, is retiring after over 40 years of service; and

**WHEREAS, Sheila Gilson** began her career with Kaiser Permanente as a bedside nurse at the South San Francisco Medical Center, moving on to successive leadership positions; and

**WHEREAS, Sheila Gilson** is known for her leadership expertise in hospital operations contributing to the enterprise-wide Care Without Delay program, accelerating curriculum for leadership development, patient care services optimization, and many more critical endeavors; and

**WHEREAS, Sheila Gilson** has served as Senior Vice President in the Redwood City Service Area since 2017 and interim Senior Vice President for the Greater Southern Alameda Service Area and South San Francisco, and under her leadership, Redwood City and South San Francisco medical centers merged into the San Mateo Service Area in August 2022; and

**WHEREAS, during Sheila Gilson’s** leadership, the service area facilities she oversaw received recognition, including: the Redwood City Medical Center was awarded the first Joint Commission Comprehensive Stroke Center designation in KP, and it has received the Healthgrades Top 100 Hospitals and Best Maternity Hospital designations; the medical center earned the KP Northern California’s Dr. Alan Whippy recognition for hospital quality for 7 consecutive years; the South San Francisco Medical Center received the Leapfrog Top Hospital Award in 2023; and in 2022 and 2023, the San Mateo Service Area was awarded the KP Northern California’s Soteria Awards for care experience, patient and workplace safety; and

**WHEREAS, Sheila Gilson** previously served on Skyline College’s President’s Advisory Council for several years and on the Hospital Consortium of San Mateo County. Currently, Sheila is a member of the San Mateo section of the Hospital Council — Northern & Central California
