DATED JULY 1, 2021

THIS FIRST AMENDMENT OF LOCAL AGREEMENT is made and entered into as of the latest date of execution set forth below, by and between the COUNTY OF SAN MATEO which is a political subdivision of the State of California (“County”) and THE REGENTS OF THE UNIVERSITY OF CALIFORNIA (“UC”), on behalf of its UC Agriculture and Natural Resources (“ANR”), and its UC Cooperative Extension – San Mateo County (“UCCE”).

The parties hereby agree as follows:


1. The Local Agreement (“Agreement”) between the parties dated July 1, 2021, which relates to the partnership to deliver the UCCE program within the County, is hereby amended as follows:
  - a. In the preamble to the Agreement, and in Section VII.E. of the Agreement, “Term,” the commencement date of July 1, 2021 is deleted and replaced with July 1, 2023, and the expiration date of June 30, 2023 is deleted and replaced with June 30, 2025.
  - b. Section IV.B.2 of the Agreement is deleted in its entirety and replaced with the following text: “Direct funding will be transferred from San Mateo County to the University on a biannual basis in amount stated in Attachment B-1 for the period July 1, 2023 to June 30, 2025.”
  - c. Section XII.A of the Agreement, “Notices/For University,” is deleted in its entirety and replaced with the following text:

“UCCE San Mateo  
ATTN: Igor Lacan, Interim County Director  
1500 Purisima Creek Road  
Half Moon Bay, CA 94019”
  - d. Attachment B to the Agreement, “Direct (Monetary) Support Provided by San Mateo County,” is deleted in its entirety and replaced with the attached Attachment B-1.
2. Except as expressly amended above, the Local Agreement remains in full force and effect.




