

**AMENDMENT NO. 2 TO THE AGREEMENT BETWEEN
THE COUNTY OF SAN MATEO AND AECOM TECHNICAL SERVICES, INC**

THIS AMENDMENT TO THE AGREEMENT, entered into the 19th day of October, 2021, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and AECOM TECHNICAL SERVICES, hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof; and

WHEREAS, the parties entered into an Agreement for providing construction management services for various County on-call projects on October 19, 2021 in the amount of \$1,500,000 and with a term of October 19, 2021 through October 18, 2024; and

WHEREAS, the parties entered into Amendment No. 1 to the Agreement for providing construction management services for various County on-call projects on October 3, 2023 in the amount of \$700,000; and

WHEREAS, the parties wish to amend the Agreement to increase the Agreement amount by \$640,000 for a total contract amount not-to-exceed of \$2,840,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. The 3rd sentence of Section 3, Payments, of the Agreement is replaced to read as follows:

In no event shall County's total fiscal obligation under this Agreement exceed Two Million Eight Hundred Forty Thousand Dollars (\$2,840,000).

2. The 1st and last sentence of bullet point 3, of Exhibit B of the Agreement is replaced to read as follows:


The County's total fiscal obligation under this Agreement shall not exceed \$2,840,000 unless said amount is authorized to be increased by the County Board of Supervisors by written amendment to this Agreement. The sum of individual task order not-to-exceed fees for multiple projects that may be assigned to the Contractor shall not exceed the total \$2,840,000 not-to-exceed

amount for this Agreement without prior written approval by the County Board of Supervisors.

3. **All other terms and conditions of the agreement dated October 19, 2021, between the County and Contractor shall remain in full force and effect.**
