RE: Written Comment: Measure K Priorities

Thanks to the BOS:

The Age Forward Coalition is a broad consortium of San Mateo County (SMC) nonprofit and community organizations and advocates serving older adults, adults with disabilities, and caregivers in SMC since 2019. This year, the Age Froward Coalition identified four priorities/categories for older adults, adults with disabilities, and caregivers to address: Home and Community-Based Services, Caregiving, Transportation, and Middle-Income Older Adults. These priorities fit within the California Master Plan on Aging's five goals:

- Housing for all stages and ages
- Health reimagined
- Inclusion and equity not isolation
- Caregiving that works
- Affording aging

On behalf of the Age Forward Coalition of San Mateo County, we wish to acknowledge and thank the Board of Supervisors for hearing the need for the inclusion of older adults' distinct representation in the Measure K Priorities. Thus, thank you for adding '+Seniors' to the Children and Families Measure K priority. As stated during the listening sessions and the individual meetings with the Board of Supervisors, the following four categories remain significant areas of concern for older adults, as identified by the Age Forward Coalition:

Home and Community-Based Services: Helping older adults age in place improves their overall quality of life and allows them to maintain a sense of independence, connections to their communities, and social interactions with their friends.

 Examples of services include meals, minor home repair, transportation, classes and activities, resource information and assistance, and the loan of assistive devices. Recommending \$500,000/yr.

Transportation: Affordable access to transportation and the lack of it can contribute to isolation and challenges during emergencies.

- Need more affordable options and door-to-door transit to access senior services and healthcare facilities, especially for the rural and Coastside communities.
- Need continued funding for door-to-door, on-demand service. A possible "price tag" is \$100,000/yr. to subsidize ride-share costs for seniors in the county, including Coastside. This could provide approximately 6,600 rides to essential destinations like medical appointments, grocery stores, pharmacies, and senior recreation centers.

Caregiving: Based on the updated report from AARP, Valuing the Invaluable, there are an estimated 83,000 family caregivers in San Mateo County valued at \$1.5 billion.

- Increased respite funding to help family caregivers get breaks, recommending \$100,000/yr.
- Financial assistance for caregivers to cover unmet medical costs like home care, incontinence supplies, medical equipment, and transportation.

Middle-Income Older Adults: The Forgotten or Missing Middle or Middle-Income comprise 44% of older adults in SMC.

• Subsidized home care programs that provide in-home care for those above the Medi-Cal limits to allow them to age in place. Recommending \$300,000/yr.

Educational Session Focused on Older Adult Services in SMC:

We would also like to inform you of an educational event hosted by the Age Forward Coalition of San Mateo County. A virtual educational session will be held on November 9, 2023, 2-3:30 PM. This event will be a speed informational session, hearing from organizations in San Mateo County that support older adults, adults with disabilities, and caregivers and how these services align with California's Master Plan on Aging. A question-and-answer segment and an overview of local senior centers will follow. Registration information will be distributed in the next few weeks.


To the Board of Supervisors,

The Broadmoor Police Officer's Association (BPOA) would like highlight and support Item #15 of the upcoming San Mateo County Board of Supervisors meeting set for Tuesday, October 17th. The Item will be sponsored by Supervisor David J. Canepa, District 5 Supervisor.

Agenda Item #15, a Measure K based resolution for the adoption and authorization of a one-time grant of district-discretionary Measure K funds not to exceed \$750,000 to the Broadmoor Police Protection District to fund the continued operation of the Broadmoor Police Department; providing an exception to the criteria for district-discretionary Measure K funds to allow for advanced payment, and authorizing the County Executive or designee to execute the grant agreement. Such a grant of monies would support public safety operations for the Broadmoor Police Department.

As working police officers, it is our honor and privilege to be able to serve the residents of Broadmoor. That work would greatly benefit from the additional funding provided by a Measure K funding grant adoption in supporting operational needs and capital improvements. That work is only made better by your support!

To the Board of Supervisors:

My name is David Smith. I am a board member of the Broadmoor Property Owners Association and an associate pastor at Church of the Highlands in San Bruno. I am the chief counselor there and deal with people's anxieties on a daily basis. This email is about Item 15 on the October 17 agenda, granting \$750,000 to the Broadmoor Police Protection District. I am writing in favor of this grant for three reasons:

- 1. Public Safety -- What used to be a place of little crime is now becoming like our neighboring communities of Daly City, San Francisco, and South San Francisco. Anxiety is increasing over home burglaries, car burglaries, and car thefts, even from residents' driveways, which are on a sharp uptick. I am concerned in our community about home invasions of the elderly and other vulnerable residents. All of the police departments, including the sheriff's department, are understaffed and overworked. We need every police officer and department at this time. I know these departments are cooperating and helping each other in the pursuit and arrest of fleeing criminals. I have witnessed it myself. The whole northern part of the county will suffer if the Broadmoor Police Department is not funded. If the department has to close down, even for a little while, there is no way of providing the current level of public safety that we enjoy.
- 2. <u>Confidence in our officers</u> -- The Broadmoor PD is efficient and swift in responding to the residents here. We appreciate them and respect them. At two Town Halls, and several other meetings, the community has overwhelmingly expressed support for these officers.
- 3. <u>Self-determination for Broadmoor</u> -- This grant of \$750,000 will allow the Broadmoor Police Department to continue to function and keep us safe. We are exploring measures to increase revenue (including raising our parcel tax) and improving the budget process for the district. But we need time. My firmly held belief is that the future of Broadmoor should be decided by the citizens of Broadmoor, through voting and the democratic process.

Dear San Mateo County Board of Supervisors,

We support wholeheartedly, Supervisor David Canepa's request of \$750,000 in Measure K funds. If we do not hold on to our Broadmoor Police Department, we will be woefully underserved, as would surrounding communities where BPD helps out.

My wife and myself moved to Broadmoor in February 2009. We love this community, and we have had personal experiences with the BPPD that have enhanced our affection for our community and overall safety. As you know there is no substitute for the feeling of community within a neighborhood and the sense of cohesiveness that a good neighborhood can provide. Our number one priority in a community must be a sense of safety; BPPD provides both a sense of safety (tangible and perceived), which are well worth the relatively small parcel tax that we payout as Broadmoor property owners. Not all issues can be measured with the bottom line. We implore that the leadership group of the LAFCO take more things into consideration than the bottom line. Recently, SFGate wrote an article on the 30 most safest cities in the bay area (see

link: http://www.sfgate.com/bayarea/article/The-30-safest-suburbs-in-the-Bay-Area-6289676.php#photo-8066032). And, Broadmoor made the list, finishing ahead of cities such as Sausalito. I do not believe this is an accident.

Our Son Sam was born June 2012 and as you would expect, our feelings about our community have been further accentuated. The Broadmoor Police Department, and the service they provide to our community cannot be measured solely by the bottom line. They

have provided immediate police services, a sense of well-being, and security to our family and community in a personal manner that is lost by larger, impersonal police services that are typically representative of other cities.

Widtfeldt, Jr. I am a lifelong resident - 68 years - of Broadmoor/Garden Village and am respectfully appealing to the Board to approve the needed funding to keep the BPD viable and sustainable. My family and I have enjoyed the superb protection of the BPD for 4 generations - the 5th generation member due to be born in Broadmoor any day. This Department is essential to the safety and protection of not only Broadmoor Village residents but the entire peninsula community, as it stands as a bulwark against the insidious spread of crime out of San Francisco southward. The rapid response of the BPD means that criminal activity is apprehended IN THE ACT, not relegated to after-the fact reports, long after the criminals have left the scene. Dear Board of Supervisors,

My name is Martha Pahnke and I am a resident of Broadmoor Village in San Mateo County. My reason for submitting this appeal concerns the securing of funds for our independent police department.

I have been a Broadmoor Village resident for 34 years, and have always felt very safe living in this community. The credit is due in large part to our Broadmoor Police Department. As a single, senior, that sense of personal safety is now more important than ever. The department has always been responsive to the needs of the residents, and I have found that to be personally true on several occasions.

The looming prospect of handing over the policing of Broadmoor Village to the short staffed San Mateo County Sheriff's Department stationed in Millbrae is not an effective solution for protecting our community. Chief Michael Connolly has informed us that a response time to a call would take 11 to 13 minutes from Millbrae (and this would be going Code 3 which involves lights and siren)! This is neither a safe nor viable form of law enforcement both for residents who may be in grave danger requiring immediate intervention or for responding officers should they be required to respond Code 3 for the distance from Millbrae to Broadmoor.

Measure K was passed by the voters of San Mateo County in 2016 to (among other things) maintain emergency operations and 9-1-1 police, fire and paramedic dispatch. So far, the Broadmoor Police Department has not received any monies from this funding source. I am imploring the Board to vote in favor of securing funds to sustain the Broadmoor Police Department. The safety and lives of its residents depend upon it. Thank you.
