SECOND AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND EXEMPLAR HUMAN SERVICES LLC

THIS AMENDMENT TO THE AGREEMENT, hereinafter called "Agreement" entered into this , by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Exemplar Human Services LLC, hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof; and

WHEREAS, on July 20, 2021, the parties entered into an Agreement for the purpose of providing analytic subscription services to enable access and to utilize key performance management outcome data services, for a total obligation not to exceed \$648,000, and for the term of July 1, 2021 through June 30, 2023; and

WHEREAS, the parties amended the Agreement on May 23, 2023 to increase funding by \$222,000 for a revised total obligation not to exceed \$870,000, and extend the term of the Agreement for a revised term of July 1, 2021 through June 30, 2024; and

WHEREAS, the parties wish to further amend the Agreement to increase funding by \$228,000 for a revised total obligation not to exceed \$1,098,000, and extend the term of the Agreement by one year for a revised term of July 1, 2021 through June 30, 2025.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3 of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed ONE MILLION, NINETY-EIGHT THOUSAND DOLLARS (\$1,098,000). In the event that County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by

County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this Agreement.

2. Section 4 of the Agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 1, 2021, through June 30, 2025.

3. Exhibit B – Payments and Rates 2. b. is amended to read as follows:

Economic Self Sufficiency Reports and Performance Management - \$4,500

3. All other terms and conditions of the Agreement dated July 20, 2021, as amendment on May 23, 2023, between the County and Contractor shall remain in full force and effect.
