RESOLUTION AUTHORIZING AGREEMENTS FOR THE PURPOSES OF OPERATING THE BIG LIFT INSPIRING SUMMERS PROGRAM TO REDUCE LEARNING LOSS DURING THE SUMMER MONTHS WITH THE FOLLOWING SIX SCHOOL DISTRICTS: A) CABRILLO UNIFIED SCHOOL DISTRICT FOR THE TERM MAY 1, 2024 THROUGH AUGUST 31, 2024 IN AN AMOUNT NOT TO EXCEED \$134,285; AND B) LA HONDA-PESCADERO UNIFIED SCHOOL DISTRICT FOR THE TERM MAY 1, 2024 THROUGH AUGUST 31, 2024 IN AN AMOUNT NOT TO EXCEED \$98,568; AND C) SAN BRUNO PARK SCHOOL DISTRICT FOR THE TERM MAY 1, 2024 THROUGH AUGUST 31, 2024 IN AN AMOUNT NOT TO EXCEED \$131,964; AND D) JEFFERSON ELEMENTARY SCHOOL DISTRICT FOR THE TERM MAY 1, 2024 THROUGH AUGUST 31, 2024 IN AN AMOUNT NOT TO EXCEED \$272,998; AND E) REDWOOD CITY SCHOOL DISTRICT FOR THE TERM MAY 1, 2024 THROUGH AUGUST 31, 2024 IN AN AMOUNT NOT TO EXCEED \$90,760; AND F) SOUTH SAN FRANCISCO UNIFIED SCHOOL DISTRICT FOR THE TERM MAY 1, 2024 THROUGH AUGUST 31, 2024 IN AN AMOUNT NOT TO EXCEED \$368,276

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, in 2012, the Peninsula Partnership Leadership Council launched "The Big Lift" to improve children's third-grade reading proficiency through strategic, thoughtful, evidence-based investments in early learning and education; and

WHEREAS, The Big Lift Inspiring Summers program, overseen by the San Mateo County Libraries and implemented by the communities of six school districts set forth below, aims to engage children in inspiring learning experiences to maintain and improve academic gains and reading proficiency over the summer; and

WHEREAS, the communities are defined by school district boundaries and include the following school districts: Cabrillo Unified School District, La Honda-Pescadero Unified School District, San Bruno Park School District, Jefferson Elementary School District, Redwood City School District and South San Francisco Unified School District; and

**WHEREAS,** as part of The Big Lift, participating school districts agree to work towards the long-term goal of third grade reading success; and

**WHEREAS**, the Human Services Agency seeks authorization from the Board of Supervisors to enter into the following agreements:

- A. Cabrillo Unified School District for the term May 1, 2024 through August 31, 2024 in an amount not to exceed \$134,285;
- B. La Honda-Pescadero Unified School District for the term May 1, 2024 through August 31, 2024 in an amount not to exceed \$98,568;
- C. San Bruno Park School District for the term May 1, 2024 through August 31, 2024 in an amount not to exceed \$131,964;
- D. Jefferson Elementary School District for the term May 1, 2024 through August 31, 2024 in an amount not to exceed \$272,998;
- E. Redwood City School District for the term May 1, 2024 through August 31, 2024 in an amount not to exceed \$90,760; and
- F. South San Francisco Unified School District for the term May 1, 2024 through August 31, 2024 in an amount not to exceed \$368,276; and

WHEREAS, this Board has been presented with forms of said agreements and has examined them and approved them as to both form and content and desires to enter into the agreements.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to execute said agreements for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Director of the Human Services Agency, or designee, is authorized to execute amendments to the agreements which modify the County's maximum fiscal obligation by no more than \$25,000 (in the aggregate for each agreement), and/or modify the contract terms and/or services so long as the modified terms or services are within the current or revised fiscal provisions.
