RESOLUTION: A) AUTHORIZING AN AGREEMENT WITH THE CALIFORNIA DEPARTMENT OF FOOD AND AGRICULTURE TO PERFORM TRAPPING AND EXCLUSION INSPECTION SERVICES FOR THE REGULATED GLASSY-WINGED SHARPSHOOTER, FOR THE TERM OF JULY 1, 2025 THROUGH SEPTEMBER 30, 2026, IN AN AMOUNT NOT TO EXCEED \$348,378 IN REIMBURSEMENT FOR SERVICES PERFORMED; AND

B) DESIGNATING THE AGRICULTURAL COMMISSIONER AS THE LOCAL PUBLIC ENTITY AUTHORIZED TO RECEIVE THESE LOCAL ASSISTANCE FUNDS

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California. that

WHEREAS, since 1999, the Board has authorized annual agreements with the California Department of Food and Agriculture ("CDFA") to implement the Pierce's Disease/Glassy-winged Sharpshooter Control Program in San Mateo County, through which County staff prevent the introduction of glassy-winged sharpshooter and Pierce's disease which it vectors, by conducting detection surveys and nursery stock inspections; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance an agreement, reference to which is hereby made for further particulars, whereby the County of San Mateo agrees to perform glassy-winged sharpshooter trapping and exclusion inspection services to prevent the introduction of this economically important plant pest and disease for the CDFA as set forth in the agreement; and

WHEREAS, both parties now wish to enter into the referenced agreement for the County to conduct detection surveys and nursery stock inspections for the term of July 1, 2025, to September 30, 2026, in an amount not to exceed \$348,378 in reimbursement to the County for services performed; and

**WHEREAS**, this Board has been presented with the referenced Agreement and has examined and approved same as to both form and content and desires to enter into same.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board be and hereby is authorized and directed to execute, on behalf of the County of San Mateo, said agreement with CDFA in an amount not to exceed \$348,378 in reimbursement for the County's performance of Pierce's Disease/Glassywinged Sharpshooter Control Program services, for the term of July 1, 2025, through September 30, 2026, and the Clerk of this Board shall attest to the President's signature thereto.

**BE IT FURTHER RESOLVED** that the County Agricultural Commissioner is hereby designated as the local public entity to receive funds allocated by CDFA for local assistance with regard to Pierce's Disease/Glassy-winged Sharpshooter Control Program.

**BE IT FURTHER RESOLVED** that the County Agricultural Commissioner is hereby authorized to execute additional amendments to this agreement with CDFA

which modify the State's maximum reimbursement by no more than \$25,000 (in aggregate) and/or modify the agreement term and/or services so long as the modified term or services is/are within the current or revised fiscal provision, and provided no such amended agreement would require the expenditure or commitment of County funds.
