RESOLUTION: A) ACCEPTING THE CERTIFICATE OF THE CHIEF ELECTIONS
OFFICER AS THE STATEMENT OF THE RESULTS OF THE VOTE AS
DETERMINED BY THE OFFICIAL CANVASS OF THE MARCH 5, 2024
PRESIDENTIAL PRIMARY ELECTION; AND B) DECLARING THE PERSONS
ELECTED TO OR NOMINATED FOR CERTAIN OFFICES; AND C) DECLARING THE
RESULTS OF A LOCAL BALLOT MEASURE

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the San Mateo County Chief Elections Officer completed the official canvass of the completed returns of the votes cast at the Presidential Primary Election held in the County of San Mateo on March 5, 2024 ("Election") and prepared in accordance with law a statement of votes polled at the Election (the "Statement of the Vote"); and

WHEREAS, on April 15, 2024 a voter-initiated recount commenced in San Mateo County for the U.S. Representative 16th District Contest in the Election ("Recount"), which was completed on May 2, 2024; and

WHEREAS, the Recount resulted in seven additional votes to the certified results of the Election, which additional votes are reflected in an Amended Statement of the Vote; and

WHEREAS, the San Mateo County Chief Elections Officer has presented to this Board certified copies of the Statement of the Vote and the Amended Statement of the Vote; and

WHEREAS, the Chief Elections Officer has delivered duplicates of the certified Statement of the Vote and Amended Statement of the Vote to the California Secretary of State and will deliver duplicates to the county central committee of each political party; and

WHEREAS, the Chief Elections Officer has also determined that the number of persons who filed declarations of candidacy for certain offices does not exceed the number of positions available; and

WHEREAS, the Chief Elections Officer will deliver to each person elected a certificate of election, signed and authorized by the Chief Elections Officer; and

WHEREAS, pursuant to Elections Code Section 15400, the governing body of a jurisdiction—here, this Board of Supervisors—shall declare elected or nominated to each office voted on at each election under its jurisdiction the person having the highest number of votes for that office or the person who was otherwise duly elected or nominated, and shall also declare the results of each election under its jurisdiction as to each measure voted on at the election.

NOW THEREFORE, BE IT RESOLVED AND HEREBY ORDERED that the Deputy Clerk of the Board shall enter upon the minutes of this meeting of this Board of Supervisors said abstract or Statement of the Vote, including the Amended State of the Vote, polled at the Election.

BE IT FURTHER RESOLVED that the Statement of the Vote, including the Amended Statement of the Vote, polled shall be and is hereby adopted as the official vote of the Election.

BE IT FURTHER RESOLVED that the following named persons have received the highest number of votes for their respective offices at the Election and are hereby ordered and declared duly elected:
