**WHEREAS, GREG RANDICH** first joined San Mateo County in 1980 as an Auditor-Appraiser I in the Personal Property Section of the Assessor’s office; he was promoted to the position of Auditor-Appraiser II within two years and by 1983 transferred into the Standards Division where he excelled and was promoted to a Senior Auditor/Appraiser in no time; and

**WHEREAS, GREG RANDICH** was the “go-to” guy in the Assessor’s Office -- a smart, flexible, curious guy who could work with anyone – and did – he even helped out at Elections; and

**WHEREAS, GREG RANDICH**, was a trusted member of nearly every Assessor’s project team including the Prop 13 cleanup legislation, the Supplemental Assessment System, and the TAPIS Project. He gained technology skills, was re-classed as an Informational Technology Analyst in 2006, joined the Tech Group in 2007 and retires today as an Departmental Systems Analyst; and

**WHEREAS, GREG RANDICH** helped implement both Prop 58 and Prop 60, a law designed to protect a family’s ability to transfer assets to their children and a law to help seniors who wish to downsize their home to do so without tax penalty. He also wrote the Personal Property Procedure Manual and helped implement the EZ-Access Unsecured Property Assessment System, the first Electronic Property Statement filing system, a Filenet enhancement for Workflow processing and most recently, the APAS Assessment System; and

**WHEREAS**, on a personal note **GREG RANDICH**, a huge Giants fan, wears his colors and loves going to a game with his wife, Lori and/or their sons, Robert and David. After 37 years with the Assessor’s Office, the “All knowing and all wise” **GREG RANDICH**, is hanging up his cleats.
