RESOLUTION AUTHORIZING ON-CALL PUBLIC SAFETY EQUIPMENT AND UPFITTING SERVICE AGREEMENTS WITH PRIORITY 1 PUBLIC SAFETY EQUIPMENT, INC., CUSTOM TOPS, INC. DBA CUSTOM TRUCK, AND VA AUTOMOTIVE LLC. DBA AUTO SOUND PERFORMANCE, FOR THE TERM OF NOVEMBER 4, 2025 THROUGH NOVEMBER 3, 2030, FOR AN AMOUNT NOT TO EXCEED \$3,250,000, \$1,500,000, AND \$1,250,000, RESPECTIVELY, FOR A TOTAL AGGREGATE NOT-TO-EXCEED AMOUNT OF \$6,000,000.

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Department of Public Works (Department) is responsible for procuring and maintaining vehicles for County departments; and

WHEREAS, this includes upfitting or outfitting and modifying vehicles with specialized equipment and accessories to ensure they are fully and properly equipped for service; and

WHEREAS, upfitting and installing public safety and utility equipment requires technical expertise and experience, and the Department relies on vendors who specialize in providing these services; and

WHEREAS, the Department issued request for proposals on July 23, 2025, seeking proposals for public safety vehicle upfitting for one or more on-call contracts; and

WHEREAS, on August 13, 2025, six proposals were received, of which four met the minimum qualifications and were deemed responsive; and

WHEREAS, the Department recommends Priority 1 Public Safety Equipment, Inc., Custom Tops, Inc. DBA Custom Truck, and VA Automotive LLC DBA Auto Sound Performance as the most qualified companies to meet the County's ongoing public safety upfitting needs; and

WHEREAS, these contracts are being awarded under the County's Procurement Preference for Local Businesses Ordinance (County Code Ch. 2.89) to Priority 1 Public Safety Equipment, Inc., Custom Tops, Inc. DBA Custom Truck, and VA Automotive LLC DBA Auto Sound Performance, which are all local businesses; and

WHEREAS, the Director of Public Works has recommended that the President of the Board be authorized to execute Agreements with Priority 1 Public Safety Equipment, Inc., Custom Tops, Inc. DBA Custom Truck, and VA Automotive LLC DBA Auto Sound Performance each for the term of November 4, 2025 through November 3, 2030, for an amount not-to-exceed \$3,250,000, \$1,500,000, and \$1,250,000, respectively; and

WHEREAS, this Board has considered and concurs with the recommendation of the Director of Public Works; and

WHEREAS, this Board has approved the agreements as to form and content and desires to enter into said agreements.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as

follows:

- 1) The President of this Board of Supervisors shall be, and is, hereby authorized and directed to execute said agreements with Priority 1 Public Safety Equipment, Inc., Custom Tops, Inc. DBA Custom Truck, and VA Automotive DBA Auto Sound Performance for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.
- 2) Authority is given to the Director of Public Works, or designee, to execute amendments to the agreements to modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) per Agreement, and/or modify the agreements for services as long as the modified services is within the current or revised fiscal provision.
