

**AMENDMENT SEVEN TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
BENEFIT SERVICE CENTER**

THIS AMENDMENT TO THE AGREEMENT, entered into this ____ day of _____, 20____, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Benefit Service Center, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for providing administration of dental and vision services for In-Home Supportive Services caregivers on June 16, 2015; and

WHEREAS, the parties wish to amend the Agreement to extend the contract period , update Exhibit B, and increase contract amount.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3, Paragraph 1 of the agreement is amended to read as follows: In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A , County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B (Rev. 11/7/2023). County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed THREE MILLION SEVEN HUNDRED AND FIFTY THOUSAND DOLLARS (\$3,750,000). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement

2. Section 4, Paragraph 1 of the agreement is amended to read as follows:


Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 1, 2015, through December 31, 2024.

4. **All other terms and conditions of the agreement dated June 16, 2015 and subsequent amendments with most recent amendment dated December 13, 2022 between the County and Contractor shall remain in full force and effect.**
