

**SECOND AMENDMENT TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
EXCELLENT MAINTENANCE PRO, INC.**

THIS AMENDMENT TO THE AGREEMENT, entered into this 13 day of August, 2024, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Excellent Maintenance Pro, Inc., hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for janitorial services on October 1, 2021 for the term of October 1, 2021, through January 31, 2022 in an amount not to exceed \$200,000; and

WHEREAS, the parties amended the Agreement on January 11, 2022 to include the additional services, extend the term through September 30, 2024, and increase the maximum amount payable under the Agreement by \$2,500,000, to an amount not to exceed \$2,700,000; and

WHEREAS, the parties wish to amend the Agreement to extend the term of the agreement by 2 years through September 30, 2026 and increase the amount of the agreement by \$1,870,000 to an amount not to exceed \$4,570,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3. Payments, of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed FOUR MILLION FIVE HUNDRED SEVENTY THOUSAND DOLLARS (\$4,570,000). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement. All invoices must be approved by the Safety Officer or their designee. Invoices must be sent to: SMMC-Accounts-Payable@smcgov.org. Processing time may be delayed if invoices are not submitted electronically.

2. Section 4. Term, of the agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from October 1, 2021, through September 30, 2026.

3. Revised Exhibit A (rev. 11/16/21) and Revised Exhibit B (rev. 11/16/21) are replaced in their entirety with Revised Exhibit A (rev. 3/27/24) and Revised Exhibit B (rev. 3/27/24), copies of which

are attached hereto and incorporated into the Agreement by this reference.

- 4. All other terms and conditions of the agreement, as previously amended, between the County and Contractor shall remain in full force and effect.**

The Contractor is available 24 hours a day 365 days a year for any emergency response. Emergency response time will be within two (2) hours of the initial contact. The Contractor shall provide each customer with the contact information of the Area Supervisor assigned to the account.

- Contractor shall provide all labor, payroll taxes. Insurance, workers' compensation insurance, health & welfare benefits. Equipment supervision and cleaning materials required to perform contracted janitorial services.
- Contractor will refer to CDC's Best Practices for Environmental Cleaning in Healthcare Facilities toolkit on best practices for frequency of cleaning certain areas.
- Contractor personnel will meet the requirements of all pre-employment, onboarding and Annual Employee Health requirements, including N95 fit testing.
- Contractor personnel will meet all onboarding and annual training, competency requirements
- Cleaning products must be submitted for approval by the County
- The contractor is responsible for providing the pre-approved microfiber mop heads
- Consumable products such as toilet tissue, hand towels, hand soap, alcohol-based hand rub, disposable curtains, and plastic liners are not included in this agreement and County will provide these products at each facility
- Contractor shall conduct regular audits of terminal cleanings, exam rooms, general cleanliness and regulatory compliance of environment, and safety and infection control practices at least weekly. These audits should be shared with the County and the County may accompany contractor in conducting these audits/rounds if so desired. Findings are to be addressed and plans of correction shared.

ADDITIONAL SERVICES:

- For additional areas or special requests that are not within routine cleaning, Contractor shall base its prices on a per hour cost or the listed amounts whichever would be the most cost effective for SMMC. Listed below are examples that may come up as additional service, requiring a smaller specific area to be cleaned and not the entire floor, beyond the routine quarterly, semi-annual or annual contract services.
- Terminal Clean of Exam Room - \$110.00 per room, per service; \$155.00 per room after-hours
- Office Space: Steam clean carpets - \$55.00 per office, per service

- Hallway: Strip and wax floor- \$425.00 per service
- Lunchroom/Kitchen area: Strip and wax floor - \$380.00 per service
- Restroom: Clean and sanitize- \$80.00 per service (does not include overflow/water extraction)
- Restroom: Strip and wax restroom floor- \$190.00 per service
- Common Area/Lobby: strip and wax floor- \$720.00 per service
- Common Area/Lobby/Offices: Steam clean carpet - \$240.00 per service
- Emergency Services: out of normal routine cleaning, i.e. toilet overflow, water leakage, roof leakage, removal and cleaning of bodily fluids outside of the normal restroom cleaning
