

**AMENDMENT TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
CHILD CARE COORDINATING COUNCIL OF SAN MATEO COUNTY**

THIS AMENDMENT TO THE AGREEMENT, entered into this June 25, 2024 by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Child Care Coordinating Council of San Mateo County, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on September 8, 2023, the parties entered into an Agreement whereby Contractor agreed to process provider deductions for Child Care Providers United pursuant to Child Care Bulletin 23-07, for the term of July 25, 2023 through June 30, 2024 for a total obligation amount not to exceed \$31,000; and

WHEREAS, the parties wish to amend the Agreement to increase the amount by \$383,089, for a revised total obligation amount not to exceed \$414,089, and extend the term by 12 months for a revised term of July 25, 2023 through June 30, 2025.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3 – Payments of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed **FOUR HUNDRED FOURTEEN THOUSAND, EIGHTY-NINE DOLLARS** (\$414,089.00). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

2. Section 4 – Term of the Agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 25, 2023, through June 30, 2025.

3. Exhibit B- 1. is amended to read as follows:

Contractor will submit billing based on the following rates:

Amount	Term
\$7,750	Per month

4. **All other terms and conditions of the agreement dated September 8,2023, between the County and Contractor shall remain in full force and effect.**
