RESOLUTION AUTHORIZING AN AGREEMENT WITH THE TOWN OF WOODSIDE TO RECEIVE LAW ENFORCEMENT SERVICES PROVIDED BY THE SHERIFF'S OFFICE FOR A TERM COMMENCING JULY 1, 2025 THROUGH JUNE 30, 2030, WITH REIMBURSEMENT TO THE COUNTY FOR FY 2025-26 IN THE AMOUNT OF \$3,320,703 WITH REVISED CALCULATED RATES EFFECTIVE JULY 1 OF EACH YEAR OF THE TERM

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, there has been presented to this Board for consideration and acceptance, an agreement, reference to which is hereby made for further particulars, whereby the San Mateo County Sheriff's Office shall provide law enforcement services for the Town of Woodside; and

WHEREAS, the Sheriff's Office has provided contract law enforcement services to the Town of Woodside for approximately four years; and

WHEREAS, the most recent contract between the County and the Town of Woodside expired on June 30, 2025, and negotiations to renew this contract began while it was still in effect and continued after its expiration; and

WHEREAS, Town management has expressed their desire to continue contracting with the County for the provision of law enforcement services and enter into a new five-year agreement for the term of July 1, 2025 through June 30, 2030; and

WHEREAS, on an annual basis during the term of the contract, the Sheriff's Office will meet with the Town of Woodside to evaluate the contract and determine if there are any amendments necessary to address a change in costs, fees or services; and

WHEREAS, both parties now wish to enter into an agreement for the provision of law enforcement services for the term of July 1, 2025, through June 30, 2030, and reimbursement to the County in the amount of \$3,320,703 for FY 2025-26, with revised calculated rates effective July 1 of each year of the term; and

WHEREAS, this Board has been presented with a form of such agreement and has examined and approved it as to both form and content and desires to enter into the same.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Sheriff or Sheriff's designee is hereby authorized to accept or execute notices, documents, and amendments associated with this agreement under the terms set forth.

BE IT FURTHER RESOLVED that the Sheriff or Sheriff's designee is hereby authorized to negotiate an extension of this agreement for up to five (5) additional years in a form approved by the County Attorney's Office as long as the terms are substantively the same and the cost of the extended agreement is fully reimbursed by the Town.
