**AMENDMENT TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
CARPI & CLAY, INC**

THIS AMENDMENT TO THE AGREEMENT, entered into this 1 day of January, 2025, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Carpi & Clay, Inc, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for state advocacy services on January 1, 2022; and

WHEREAS, the parties amended the Agreement for state advocacy services on January 1, 2023; and

WHEREAS, the parties amended the Agreement for state advocacy services on January 1, 2024; and

WHEREAS, the parties wish to amend the Agreement to exercise the option to extend the term of services to December 31, 2025 and to increase the not to exceed amount from \$288,000 to \$384,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3 of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed THREE HUNDRED EIGHTY-FOUR THOUSAND (\$384,000.00). in the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time

of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.


2. Section 4 of the agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of the Agreement shall be from January 1, 2022, through December 31, 2025.

3. **All other terms and conditions of the agreement dated January 1, 2022, between the County and Contractor shall remain in full force and effect.**
