**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY
RESOLUTION 080517 TO DELETE FIVE POSITIONS AND ADD SEVEN POSITIONS;
AND ACCEPT THE UPDATED REPORT OF BIWEEKLY SALARIES BY
CLASSIFICATION**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 073703 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 080517 as follows:

SECTION 1: Section 14 of the Resolution is amended as indicated:

14000 CONTROLLER'S OFFICE

1. Item E350, Fiscal Office Specialist is decreased by 1 position for a new total of 3 positions.
2. Item E337, Office Specialist is decreased by 1 position for a new total of 1 position.

3. Item E030S, Accountant Series is increased by 2 for a new total of 8 positions.

55500 PUBLIC HEALTH, POLICY AND PLANNING

1. Item B076, Medical Office Specialist-Unclassified is decreased by 1 position for a new total of 0 positions.
2. Item E422, Mobile Health Services Assistant is increased by 1 position for a new total of 1 position.
3. Salary for Item F195, Mobile Clinic Certified Medical Assistant is set at \$32.17 to \$40.20 per hour.
4. Item F009S, Patient Care Series (Medical Services Assistant II) is decreased by 1 position for a new total of 14 positions.
5. Item F195, Mobile Clinic Certified Medical Assistant is increased by 1 position for a new total of 1 position.

61000 BEHAVIORAL HEALTH AND RECOVERY SERVICES

1. Item F122S, Physician Series (Adult Psychiatrist) is increased by 1 position for a new total of 29 positions.

70000 HUMAN SERVICES AGENCY

1. Item G237S, Employment Services Specialist Series is decreased by 1 position for a new total of 19 positions.
2. Item G200S, Vocational Rehabilitation Counselor Series is increased by 1 for a new total of 8 positions.
3. Item D090, Human Services Manager I is increased by 1 position for a new total of 10 positions.
