RESOLUTION AUTHORIZING: A) A SYSTEM IMPROVEMENT PLAN FOR THE PERIOD OF MARCH 6, 2023 TO MARCH 5, 2028, A COMPONENT OF THE CALIFORNIA CHILD AND FAMILY SERVICES REVIEW MANDATED UNDER ASSEMBLY BILL 636; AND B) EXECUTION OF THE NOTICE OF INTENT AUTHORIZING THE HUMAN SERVICES AGENCY TO ADMINISTER THE CHILD ABUSE PREVENTION, INTERVENTION AND TREATMENT, COMMUNITY-BASED CHILD ABUSE PREVENTION, AND PROMOTING SAFE AND STABLE FAMILY FUNDS; AND C) DESIGNATION OF THE SAN MATEO COUNTY CHILD ABUSE PREVENTION COUNCIL AS THE CHILD ABUSE PREVENTION COUNCIL AND PROMOTING SAFE AND STABLE FAMILIES COLLABORATIVE; AND D) DESIGNATION OF THE SAN MATEO COUNTY CHILD ABUSE PREVENTION COUNCIL OVERSIGHT COMMITTEE AS THE COUNTY'S CHILDREN'S TRUST FUND COMMISSION

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the California Child and Family Services Review (C-CFSR) System was formed as a result of the passage of the Child Welfare System Improvement and Accountability Act (AB 636) in 2001 and modeled after the Federal CFSR that is designed to improve outcomes for children in the child welfare system while holding county and state agencies accountable for the outcomes achieved; and

WHEREAS, the statewide accountability system includes the completion of a County Self-Assessment (CSA) which includes a peer review, development of a five-year System Improvement Plan (SIP), the submission of annual SIP Progress

Reports, and quarterly monitoring of SIP strategies and the effects on Child Welfare outcomes; and

WHEREAS, the County's Self- Assessment was completed by the Human Services Agency (HSA) and approved by the California Department of Social Services (CDSS) on March 5, 2023; and

WHEREAS, the System Improvement Plan is a collaborative effort between the Human Services Agency and Juvenile Probation that establishes the County's commitment to address specific, measurable, improvements in performance outcomes to be achieved within a designated timeframe; and

WHEREAS, the County has the responsibility to designate a community entity as the County's Children's Trust Fund Commission, Child Abuse Prevention Council, and Promoting Safe and Stable Families (PSSF) Collaborative; and

WHEREAS, this Board determines it is in the best interest of the County to approve the SIP so as to remain in compliance with the CDSS comprehensive outcome and accountability process, as articulated in the C-CFSR; and

WHEREAS, this Board determines it is in the best interest of the County to designate the San Mateo County Child Abuse Prevention Council (SMCCAPC) as the Child Abuse Prevention Coordinating Council and County's PSSF Collaborative and

designate the SMCCAPC Oversight Committee as the County's Children's Trust Fund Commission.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of this Board of Supervisors is hereby authorized to execute the System

Improvement Plan and California Department of Social Services Notice of Intent Form on behalf of the County of San Mateo, and the clerk of this Board shall attest the

President's signature thereto.

BE IT FURTHER DETERMINED AND ORDERED that the San Mateo County

Child Abuse Prevention Council (SMCCAPC) is hereby designated as the Child Abuse

Prevention Council and PSSF Collaborative, and that the SMCCAPC Oversight

Committee is hereby designated as the County's Children's Trust Fund Commission for the period of March 6, 2023 through March 5, 2028 to coincide with the term of the SIP.
