RESOLUTION: A) RESCINDING IN PART THE "1-HOUR TIME LIMITED PARKING"
ZONE ON THE NORTHWESTERLY SIDE OF FIFTH AVENUE COMMENCING AT A
POINT 33 FEET SOUTHWESTERLY OF THE INTERSECTION OF GLENDALE
AVENUE AND EXTENDING SOUTHWESTERLY A DISTANCE OF 97 FEET, MORE
OR LESS, WITHIN THE UNINCORPORATED NORTH FAIR OAKS AREA THAT WAS
PREVIOUSLY APPROVED BY THIS BOARD BY RESOLUTION NO. 067696 ON
DECEMBER 6, 2005; AND B) ESTABLISHING A "2-HOUR TIME LIMITED
PARKING" ZONE ON THE NORTHWESTERLY SIDE OF FIFTH AVENUE
COMMENCING AT A POINT 33 FEET SOUTHWESTERLY OF THE INTERSECTION
OF GLENDALE AVENUE AND EXTENDING SOUTHWESTERLY A DISTANCE OF
145 FEET, MORE OR LESS, BETWEEN 8:00 AM TO 5:00 PM, SATURDAYS,
SUNDAYS, AND HOLIDAYS EXCEPTED

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507 et seq. and Section 7.24.010 et seq. of the San Mateo County Ordinance Code allow this Board of Supervisors to prohibit or restrict the stopping, parking or standing of vehicles by resolution or ordinance with associated signs and markings; and

WHEREAS, Resolution No. 067696, adopted by this Board on December 6, 2005, established 1-hour time limited parking along Fifth Avenue commencing at a point 33 feet southwesterly of the intersection of Glendale Avenue and extending southwesterly a distance of 97 feet, more or less, between the hours of 8:00 AM and 5:00 PM, Saturdays, Sundays, and holidays excepted, and

WHEREAS, the Director of Public Works has recommended rescinding, in part, said Resolution No. 067696 relative to the "1-Hour Time Limited Parking" zone as noted herein and as depicted on Exhibit A attached hereto; and

WHEREAS, the Director of Public Works has recommended that a "2-Hour Time Limited Parking" zone be established as noted herein and as depicted on Exhibit A attached hereto; and

WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

- 1. The "1-Hour Time Limited Parking" zone established per Resolution No. 067696, on December 6, 2005, shall be rescinded in part at the following location:
 - "On the northwesterly side of FIFTH AVENUE commencing at a point 33 feet southwesterly of the intersection of GLENDALE AVENUE and extending southwesterly a distance of 97 feet, more or less, between the hours of 8:00 A.M. and 5:00 P.M., Saturdays, Sundays, and holidays excepted."
- 2. The "2-Hour Time Limited Parking" zone shall be established at the following location: "On the northwesterly side of Fifth Avenue commencing at a point 33 feet southwesterly of the intersection of Glendale Avenue and extending southwesterly a distance of 145 feet, more or less, between 8:00 A.M. to 5:00 P.M., Saturdays, Sundays, and holidays excepted."
- The Director of Public Works is authorized and directed to post any necessary signs and pavement markings.
