RESOLUTION ESTABLISHING “NO PARKING” ZONES ON THE EASTERLY SIDE OF OBISPO ROAD COMMENCING AT A POINT 55 FEET NORTHERLY OF THE OBISPO ROAD AND CORONADO STREET INTERSECTION AND EXTENDING NORTHERLY A DISTANCE OF 50 FEET, MORE OR LESS AND COMMENCING AT A POINT 190 FEET NORTHERLY OF THE OBISPO ROAD AND CORONADO STREET INTERSECTION AND EXTENDING NORTHERLY A DISTANCE 270 FEET, MORE OR LESS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507, et seq., and Section 7.30.010 of the San Mateo County Ordinance Code allow this Board of Supervisors to prohibit or restrict the stopping, parking, or standing of vehicles by resolution or ordinance with associated signs and markings; and

WHEREAS, the Coastside Fire Protection District (Coastside Fire) seeks to improve emergency vehicle access to and from their Fire Station #41 on Obispo Road near Coronado Street in the unincorporated El Granada area; and

WHEREAS, the Department of Public Works (Department) has evaluated the area between the southerly driveway of Fire Station #41 and Coronado Street and determined that restricting parking along a portion of Obispo Road will improve vehicle clearance for emergency vehicles, including those accessing Highway 1; and

WHEREAS, the Department had identified approximately 270 feet of existing red curb along Obispo Road between Fire Station #41's two driveways that was not established per resolution and has determined that the parking restriction in this area is warranted and supports emergency vehicle access; and

WHEREAS, the Director of Public Works has recommended that "No Parking" zones be established as noted herein and on Exhibit A attached hereto; and

WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1. A "No Parking" zone is declared to exist on the easterly side of Obispo Road (County Road R-105C) commencing at a point 55 feet northerly of the centerline of Coronado Street and extending northerly on Obispo Road a distance of 50 feet, more or less.
2. A "No Parking" zone is declared to exist on the easterly side of Obispo Road (County Road R-105C) commencing at a point 190 feet northerly of the centerline of Coronado Street and extending northerly on Obispo Road a distance of 270 feet, more or less.
3. The Department of Public Works is authorized and directed to post any necessary signs and pavement markings.
