## First Amendment to Agreement Between the County of San Mateo and Jacqueline Baras Shreibati, MD for Cardiology Services

THIS AMENDMENT TO THE AGREEMENT, entered into this <u>24th</u> day of <u>September 2024</u>, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and **Jacqueline Baras Shreibati, MD**, hereinafter called "Contractor";

## $\underline{W} \underline{I} \underline{T} \underline{N} \underline{E} \underline{S} \underline{S} \underline{E} \underline{T} \underline{H}$ :

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for cardiology services for the term of July 1, 2024 through June 30, 2027, in an amount not to exceed \$ 349,356.00 (the "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to add additional capacity for supplemental clinical services and, accordingly, increase the "not to exceed" amount of the Agreement by \$80,000.00

## NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. <u>EXHIBIT A</u> (entitled **SERVICES**) Section II. e. (entitled **Supplemental Services**) is hereby added as follows:
  - e. **Supplemental Services**: At the request of the Chief Medical Officer, Medical Director of Specialty Services, or designee; Contractor may provide up to and not to exceed ninety-six (96) hours per Contract Year of compensated clinical services in addition to the Clinic Blocks and Reading Blocks set forth, above (each, a "Supplemental Service"). Such Supplemental Services may be in the form of extensions of Clinic Blocks or Reading Blocks, additional four-hour Clinic Blocks or Reading Blocks, and/or additional clinical or patient care services. The parties acknowledge that there might be circumstances where Contractor must provide more than ninety-six (96) hours of Supplemental Services in a Contract Year, and that any Supplemental Services provided beyond the ninety-sixth (96<sup>th</sup>) hour in a given Contract Year shall be uncompensated.

- 2. <u>EXHIBIT B</u> (entitled <u>Payments</u>) Section II. d. (entitled <u>Supplemental Services</u>) is hereby added as follows:
  - d. **Supplemental Services**: Approved Supplemental Services will be compensated at a rate of TWO HUNDRED EIGHTY-NINE DOLLARS (\$ 289.00) per hour.
- **3. EXHIBIT B** (entitled **PAYMENTS**) Section I. is hereby amended to read as follows:

Total payment for services under this Agreement will not exceed FOUR HUNDRED TWENTY NINE THOUSAND THREE HUNDRED FIFTY-SIX DOLLARS (\$ 429,356.00).

4. All other terms and conditions of the Agreement shall remain in full force and effect.
