

**Third Amendment to Agreement  
Between the County of San Mateo and Sutter Bay Medical Foundation, a California  
nonprofit public benefit corporation dba Palo Alto Medical Foundation for Health  
Care, Research and Education for Vascular Surgery Services**

THIS AMENDMENT TO THE AGREEMENT, entered into this \_\_\_\_\_ day of \_\_\_\_\_ 2026, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Sutter Bay Medical Foundation, a California nonprofit public benefit corporation dba Palo Alto Medical Foundation for Health Care, Research and Education, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for vascular surgery services for the term of September 1, 2022 through August 31, 2025, in an amount not to exceed \$ 1,350,000.00 (the "Agreement"); and

WHEREAS, on January 28, 2025 the parties amended the agreement to update the contractor provider list and increase the "not to exceed" amount of the agreement by \$200,000 to an amount not to exceed \$1,550,000.00; and

WHEREAS, on August 26, 2025 the parties further amended the agreement to extend the term by three months and proportionately increase the "not to exceed" amount of the agreement by \$ 129,167.00 with no change in compensation formula to account for the extended term; and

WHEREAS, additional approved funds in the amount of \$35,107.00 must be added to the "not to exceed" amount to cover services provided through November 30, 2025

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

**1. EXHIBIT B (entitled **PAYMENTS**) Section IV. is amended to read as follows:**

Total payment for services under this Agreement will not exceed ONE MILLION SEVEN HUNDRED FOURTEEN THOUSAND TWO HUNDRED SEVENTY-FOUR DOLLARS (\$1,714,274.00).

2. All other terms and conditions of the Agreement shall remain in full force and effect.
