**RESOLUTION RATIFYING THE ORDINANCE CODES OF THE COASTSIDE FIRE PROTECTION DISTRICT, MENLO PARK FIRE PROTECTION DISTRICT, WOODSIDE FIRE PROTECTION DISTRICT, AND REDWOOD CITY FIRE DEPARTMENT FOR ENFORCEMENT WITHIN THE UNINCORPORATED AREAS OF SAN MATEO COUNTY LYING WITHIN THEIR JURISDICTIONAL BOUNDARIES AND DELEGATING ENFORCEMENT TO EACH RESPECTIVE FIRE CHIEF**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, there are four fire protection districts that provide fire protection within unincorporated areas of the County: specifically, the Coastside Fire Protection District, Menlo Park Fire Protection District, Woodside Fire Protection District, and Redwood City Fire Department; and

**WHEREAS**, pursuant to California Health and Safety Code Section 13869.7, each of these districts has the authority to adopt its own ordinance, which among other things, incorporates and amends the California Fire Code to address local conditions throughout the district; and

**WHEREAS**, the adopted ordinances of these districts are not effective in the portions of these districts' territory that lies within the unincorporated areas of San Mateo County until the ordinances are ratified by San Mateo County; and

**WHEREAS**, each of these fire protection districts have amended its ordinance code to incorporate changes to the 2022 California Fire Code; and

**WHEREAS**, each of these fire protection districts seeks ratification of its ordinance code so that the code will be effective in the portions of the district's territory lying within the unincorporated areas of San Mateo County; and

**WHEREAS**, this Board has reviewed the ordinance codes of each of these fire protection districts, copies of which are Attachments A through D to this Resolution, and desires to ratify them.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the County of San Mateo ratifies the ordinance codes of the Coastside Fire Protection District, the Menlo Park Fire Protection District, the Woodside Fire Protection District, and Redwood City Fire Department, and that a copy of each district's findings and ordinance be filed with the California Building Standards Commission; and

**IT IS FURTHER DETERMINED AND ORDERED** that the Fire Chief of each district, or their authorized representative, is hereby delegated authority to enforce the respective ordinances.
