The funding will be a loan bearing 3% simple interest repaid through residual receipts during the loan's 55-year term. A 1.5% loan fee will be withheld from the loan proceeds for the County's administrative costs, and a monitoring fee of \$250 per AHF-Restricted Unit, capped at \$5,000, is due annually.
