**RESOLUTION AUTHORIZING A ONE-TIME GRANT OF DISTRICT-DISCRETIONARY MEASURE K FUNDS, NOT TO EXCEED \$34,366, TO AYUDANDO LATINOS A SOÑAR (ALAS) TO PURCHASE EQUIPMENT NECESSARY FOR THE ALAS ECONOMIC VITALITY INITIATIVE, AND AUTHORIZING THE COUNTY MANAGER, OR DESIGNEE, TO EXECUTE THE GRANT AGREEMENT**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, Measure K is the half-cent general sales tax initially approved by San Mateo County voters in November 2012, and extended in November 2016 for a total of thirty years; and

**WHEREAS**, the Board and County staff have conducted study sessions and community outreach efforts to inform priorities for Measure K spending; and

**WHEREAS**, on March 9, 2021, and March 23, 2021, the Board held study sessions on Measure K expenditures and anticipated revenue for fiscal years (FY) 2021-23, and approved the allocation of \$5 million in one-time loans or grants for the FY 2021-23 budget cycle, divided equally among the supervisorial districts, for district-discretionary needs and projects; and

**WHEREAS**, Supervisorial District 3 has requested a one-time \$34,366 grant to Ayudando Latinos a Soñar (ALAS) to purchase equipment necessary for the ALAS Economic Vitality Initiative; and

**WHEREAS**, this item is consistent with the criteria for district-discretionary Measure K funds approved by the Board in December 2018; and

**WHEREAS**, there are sufficient Measure K funds in the Non-Departmental Services FY 2021-22 Adopted Budget; and

**WHEREAS**, it is the Board's intent for the County Manager, or designee, to execute an agreement in the amount of \$34,366 to Ayudando Latinos a Soñar and setting for the terms of the grant in furtherance of the objectives set forth in the Board transmittal; and

**WHEREAS**, this Board has been presented with a form of the grant agreement and has examined it and approved it as to both form and content and desires to enter into the agreement.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors approves of said grant, and authorizes the County Manager, or designee, to execute the agreement.

**BE IT FURTHER RESOLVED** that the County Manager or designee is authorized to execute amendments to the grant agreement which modify the County's maximum fiscal obligation by no more than ten percent (10%) or \$25,000 (in aggregate), whichever is less, and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
