

**FIRST AMENDMENT TO AGREEMENT  
BETWEEN THE COUNTY OF SAN MATEO AND  
RAPE TRAUMA SERVICES**

THIS FIRST AMENDMENT TO THE AGREEMENT, entered into this date \_\_\_\_\_, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Rape Trauma Services, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on February 5, 2026, the parties entered into a director-level agreement (Agreement) for a term of February 1, 2026 to June 30, 2026, for a total obligation amount not to exceed \$105,429 for the purpose of maintaining a 24-hour crisis line and providing other services in connection with the County’s Commercially Sexually Exploited Children (CSEC) program; and

WHEREAS, the parties wish to amend the Agreement (First Amendment) to increase the term by 36 months for a new term of February 1, 2026 to June 30, 2029, and increase funding by \$821,858 for a new total amount of \$927,287.

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

1. Section 3. **Payments** is hereby amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A and Attachments D, H, I and P, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County’s total fiscal obligation under this Agreement exceed **NINE HUNDRED TWENTY-SEVEN THOUSAND TWO HUNDRED EIGHTY-SEVEN DOLLARS (\$927,287)**. In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination

or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

- Paragraph **4. Term** is hereby amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from February 01, 2026, through June 30, 2029

- Exhibit A, paragraph I. Performance Measures, number 2 is hereby amended to read as follows:

Contractor will submit quarterly reports on a template provided by San Mateo County to include key indicator data on service areas and progress towards performance measure goals

- Exhibit B, paragraph 4. Budget Table, is hereby amended to read as follows:
