RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH KARLA'S JANITORIAL & SUPPLIERS, LLC. FOR CUSTODIAL SERVICES AT VARIOUS COUNTY OWNED AND LEASED FACILITIES INCREASING THE NOT-TO-EXCEED AMOUNT BY \$255,609.72 FOR A NEW NOT-TO-EXCEED AMOUNT OF \$1,854,589.80 AND EXTENDING THE TERM THROUGH OCTOBER 31, 2025

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Department of Public Works (Department) is responsible for providing and managing contract custodial services for ten County owned and leased facilities; and

WHEREAS, on September 28, 2021, this Board adopted Resolution No. 078455 authorizing an Agreement with Karla's Janitorial & Suppliers, LLC. (Karla's) for contract custodial services for ten County facilities; and

WHEREAS, the Agreement provides for service at the following facilities:

South County Facilities - East Palo Alto Government Building, Agriculture/Weights and Measures, Canyon Oaks, Vocational Rehabilitation; North County Facilities - Safe Harbor, Aging and Adult Services Warehouse, Human Services Agency on 92nd Avenue in Daly City, Adult Probation/Tax Collector/District Attorney in South San Francisco; and

WHEREAS, as authorized by Resolution No. 078455, the Director of Public Works executed Amendment Nos. 1 and 2 increasing the not-to-exceed amount by \$300,000 and extending the term of the Agreement through April 30, 2025; and

WHEREAS, Karla's contract expires on April 30, 2025, and their authorized funding has been fully utilized; and

WHEREAS, to ensure uninterrupted janitorial services, the Department is recommending an amendment to the Agreement with Karla's; and

WHEREAS, the Director of Public Works recommends an amendment increasing the not-to-exceed amount of the Agreement by \$255,609.72 for a new not-to-exceed amount of \$1,854,589.80 and extending the term of the Agreement through October 31, 2025; and

WHEREAS, this Board has considered and concurs with the recommendation of the Director of Public Works.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors shall be, and is, hereby authorized and directed to execute said Amendment No. 3 to the Agreement with Karla's Janitorial & Suppliers, LLC. on behalf of the County of San Mateo and the Clerk of this Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Director of Public Works, or designee, is authorized to execute contract amendments to modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract for services, as long as the modified term of services is/are within the current or revised fiscal provision.
