RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH JOBTRAIN, INC. TO PROVIDE PROGRAMS AND SERVICES TO SAN MATEO COUNTY'S INCARCERATED POPULATION, FOR THE TERM OF FEBRUARY 1, 2025, THROUGH JUNE 30, 2026, IN AN AMOUNT NOT TO EXCEED \$672,203

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, in the Fall of 2024, the Sheriff's Office issued a Request for Proposals (RFP) for programs and services for the County's incarcerated population, reflecting the County's commitment to serving the justice-involved population; and

WHEREAS, JobTrain, Inc. was selected from the joint RFP to provide Culinary Arts and Hospitality, Work Readiness and Financial Literacy, Life Skills, and other vocational and career counseling services to incarcerated individuals, thereby helping them to develop marketable skills and prepare them to enter the workforce upon release; and

WHEREAS, the Sheriff's Office presents to this Board of Supervisors for its consideration and acceptance an agreement with JobTrain, Inc. for the term February 1, 2025, through June 30, 2026, in a total amount not to exceed \$672,203; and

WHEREAS, JobTrain, Inc. is commencing year one of services to the justice-involved population under the Request for Proposals selection; and

WHEREAS, this Board wishes to approve an agreement with JobTrain, Inc.

pursuant to which that contractor will provide direct services to the incarcerated, such as

Arts and Hospitality, Work Readiness and Financial Literacy, Life Skills, and other

vocational and career counseling services; and

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors be and is hereby authorized and directed to execute said Agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Sheriff or Sheriff's designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract terms and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
