**RESOLUTION AUTHORIZING THE PRESIDENT OF THE BOARD OF  
SUPERVISORS TO EXECUTE AGREEMENTS THROUGH THE JUVENILE  
PROBATION AND CAMP FUNDING (JPCF):**

**A) AN AGREEMENT WITH FRESH LIFELINES FOR YOUTH, INC. TO PROVIDE  
CONTINUOUS LAW PROGRAM CURRICULUM AND 10-MONTH INDIVIDUALIZED  
LEADERSHIP PROGRAMS FOR THE TERM OF JULY 1, 2023, THROUGH JUNE 30,  
2026, IN AN AMOUNT NOT TO EXCEED \$267,824; AND B) AN AGREEMENT WITH  
STARVISTA TO PROVIDE A COMPREHENSIVE SCHOOL-BASED PROGRAM  
CALLED STRENGTHEN OUR YOUTH IN WHICH CLINICIANS WORK WITH AT-  
RISK YOUTH, SCHOOL STAFF, AND PROVIDE PARENTAL ENGAGEMENT FOR  
THE TERM OF JULY 1, 2023, THROUGH JUNE 30, 2026, IN AN AMOUNT NOT TO  
EXCEED \$770,700; AND C) AN AGREEMENT WITH URBAN SERVICES YMCA OF  
SAN FRANCISCO TO PROVIDE AN EARLY INTERVENTION MIDDLE SCHOOL-  
BASED PROGRAM CALLED SCHOOL SAFETY ADVOCATES IN WHICH  
CLINICIANS WORK WITH AT-RISK YOUTH, SCHOOL STAFF, AND PARENTS FOR  
THE TERM OF JULY 1, 2023, THROUGH JUNE 30, 2026, IN AN AMOUNT NOT TO  
EXCEED \$712,027**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of  
California, that

**WHEREAS**, in November 2022, the Probation Department released a request  
for proposals (RFP) for programs and services to be funded through the county's annual  
Juvenile Probation and Camp Funding (JPCF) allocation; and

**WHEREAS**, Fresh Lifelines for Youth, Inc., StarVista, and Urban Services  
YMCA of San Francisco have been selected through this RFP to provide services to at-  
risk youth in the community; and

**WHEREAS**, the Probation Department and Fresh Lifelines for Youth, Inc. wish  
to enter into an Agreement to provide Law and Leadership Programs for the term of July  
1, 2023, through June 30, 2026, in an amount not to exceed \$267,824.00; and

**WHEREAS**, the Probation Department and StarVista wish to enter into an Agreement to provide a comprehensive school-based program called Strengthen Our Youth (SOY) whereby clinicians work with at-risk youth, school staff, and provide parental engagement for the term of July 1, 2023, through June 30, 2026, in an amount not to exceed \$770,700.00; and

**WHEREAS**, the Probation Department and Urban Services YMCA of San Francisco wish to enter into an Agreement to provide an evidence-based practice curriculum called Scholl Safety Advocates in middle school whereby clinicians work with at-risk youth, school staff and families to provide early intervention services for the term of July 1, 2023, through June 30, 2026, in an amount not to exceed \$712,027.00; and

**WHEREAS**, the Board has been presented with these Agreements and has approved them as to both form and content and desires to enter into the Agreements.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of the Board is hereby authorized and directed to execute said Agreements for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Chief Probation Officer or his designee is authorized to execute contract amendments that modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) for each contract, and/or modify each contract's term and/or services so long as the modified terms of service are within the current or revised fiscal provisions.
