**MEASURE K: RESOLUTION AUTHORIZING THE DISTRICT ATTORNEY, OR DESIGNEE, TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE CITY OF REDWOOD CITY TO PROVIDE FIREARM RELINQUISHMENT AND ENFORCEMENT SERVICES TO SUPPORT THE SAN MATEO COUNTY GUN RELINQUISHMENT TASK FORCE, FOR THE TERM OF FEBRUARY 24, 2025 TO FEBRUARY 24, 2026 IN AN AMOUNT NOT TO EXCEED \$350,000 ALONG WITH TWO OPTIONS TO EXTEND THE AGREEMENT FOR ONE YEAR PER OPTION, IN AN AMOUNT OF \$350,000 FOR EACH OPTION, IF EXERCISED, AT THE SOLE DISCRETION OF THE DISTRICT ATTORNEY OR DESIGNEE**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the San Mateo County Gun Relinquishment Task Force (GRTF) is a unit, within the San Mateo County District Attorney's Office, led by the District Chief Inspector or Senior Inspector ("DA Inspector") comprised of law enforcement officers from the County and its cities and towns; and

**WHEREAS**, the purpose of the GRTF is to coordinate and share resources among the law enforcement agencies in the County to more effectively enforce unlawful firearm possession laws, in the interest of promoting safety and reducing gun violence in the County; and

**WHEREAS**, the County has partnered with the City of Redwood City to assign one or more peace officer "Officer(s)" to the GRTF to staff the GRTF and support its efforts related to enforcing state and local firearm laws, firearms relinquishment, detection of armed prohibited persons, and to improve coordination among the various local law enforcement agencies within the County; and

**WHEREAS**, this Board has been presented with an agreement with the City of Redwood City as described in the board memorandum accompanying this resolution, in an amount not to exceed \$350,000 for a term of February 24, 2025 to February 24, 2026, and a cumulative amount not to exceed \$1,050,000 if the District Attorney exercises either or both of the options provided in the agreement, and has examined it and approved it as to both form and content and desires to enter into the agreement; and

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of the Board of Supervisors be and is hereby authorizes and directed to execute said agreement with the City of Redwood City and the Clerk of the Board shall attest to the President's signature thereto.

**BE IT FURTHER RESOLVED** that the County Executive or designee is authorized to exercise the contractual options set forth in the agreements at their sole discretion and is further authorized to execute amendments to the agreements which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate per agreement), and/or modify the contract term and/or services, so long as the modified contract term or services is/are within the current revised fiscal provisions.

**BE IT FURTHER RESOLVED** that the District Attorney (DA) or DA's designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term of services is/are within the current or revised fiscal provisions.


