

**SECOND AMENDMENT TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
ADOBE SERVICES**

THIS AMENDMENT TO THE AGREEMENT, entered into this day of TuesdayTuesday, June 9, 2026, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Abode Services, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on June 25, 2024, the parties entered into an Agreement for the purpose of providing housing location services, move-in and rental financial assistance and housing-focused case management for the term of July 1, 2024 through June 30, 2025 for a total fiscal obligation not to exceed \$609,744; and

WHEREAS, on June 10, 2025, the parties amended the Agreement to add \$571,975.49 in funds for a revised total fiscal obligation of \$1,181,719.49, and to extend the term of the Agreement through June 30, 2026; and

WHEREAS the parties wish to amend the Agreement to add \$352,393 in funds for a revised total fiscal obligation of \$1,534,113 and to extend the term of the Agreement by one year through June 30, 2027.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- Section 3. Payments** of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed **ONE MILLION FIVE HUNDRED THIRTY-FOUR THOUSAND ONE HUNDRED THIRTEEN DOLLARS (\$1,534,113)**. In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed

by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

2. Section 4. Term of the agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 1, 2024, through June 30, 2027.
